# **Interview Protocol: Service Providers**

Thank you for the opportunity to speak with you today. Our interview should last no longer than 60 minutes. Before we begin, please let me give you a brief background on the reason for this interview.

You are probably familiar with the Governor's Regional Prosperity Initiative (RPI), which is a competitive grant process to encourage local private, public, and non-profit partners to work together for the betterment of the regional economy. As a part of this Initiative, the state was divided into 10 regions and you are in Region 6, which includes Genesee, Huron, Lapeer, Sanilac, Shiawassee, St. Clair, and Tuscola counties.

The Upjohn Institute has been selected to lead the process in the development of a Regional Prosperity Plan (RPP) for Region 6. Honestly, we see our task as the development of an "economic and workforce development outreach and response system" for the region. This interview is part of our "Listening Tour," the first step in the planning process. We will be speaking to as many as 40 representatives from the region's economic development, workforce development, education, and transportation planning organizations during this phase of the planning process. We are making every effort to speak with people and organizations in these sectors across the seven counties to engage as many voices as possible.

At the same time, work is underway in the development of the Comprehensive Economic Development Strategy (CEDS) for much of the region. While the purpose of the CEDS is to ensure that the region's economic development projects receive proper consideration for funding by the Economic Development Administration (EDA), there is strong overlap between the two activities. We are working closely with the CEDS planning team to ensure that our efforts are complementary and not duplicative.

We see the RPP planning process as an opportunity for partnering organizations to identify their role within the region and to construct a regional plan or system that would enable them to reach their economic potential.

#### SUMMARY OF REGION 6 - REGIONAL PROSPERITY MEETING

The Region 6 Regional Prosperity Steering Committee met at 10:00 a.m. on Thursday, July 24, 2014, at the Lapeer County Health Department.

Chairperson Osentoski called the meeting to order at 10:04 a.m.

#### I. Introductions

Committee members introduced themselves.

#### II. Forecasting and Visioning using the Region 6 REMI model

Mr. George Erickcek reviewed the agenda for the meeting and presented topics for discussion.

Discussion was held on where is the next generation of farmers coming from. The average age of farmers from 1992 to 2012 were reviewed. All of the seven counties showed current farmers were ages 56–58 years old.

A chart was reviewed showing a breakdown of the principal occupation of farm managers in the seven counties. This chart showed that between 44% & 51% of farmers has a non-farming principal occupation. Computer technology is being used greatly in the farming community over the past several years.

Agricultural production was discussed. Yields of grains have increased dramatically within the last ten years. An example is that in the past an acre of land would produce 150 bushels, and now an acre of land is producing 300 bushels. The man hours of farming is less now with larger yields being produced. This is allowing farmers to have other occupations along with farming.

Commuting patterns were reviewed for the Region 6 area. The chart showed the employed workforce by county of residency and if working in the Thumb area, the I-69 Corridor or outside Region 6. It was suggested that the I-69 corridor section needs to be broken down into within their county or outside their county of residency.

Mr. George Erickcek explained the REMI forecasting model vs other modeling tools. There will be two models done; one for the thumb area and one for the I-69 corridor. Future forecasting is extremely difficult. In the future schools are going to be smaller and will struggle. There will be a large demand on assisted living as the baby boomers get older. Also will the younger generation have the experience to replace the current workers as they retire? Population & Employment forecasts were reviewed.

#### III. <u>Update on Listening Tour</u>

Mr. George Erickcek gave an update on the listening tour. The update included communities that have had listening sessions and communities that will be having listening sessions. It is felt that the listening session have been extremely information and helpful.

#### IV. Focus Group Discussion – Review of the expected final product

Mr. George Erickcek lead a brain storming session on what alternative futures the committee would like to see used in the REMI model.

- 1. Some energy company appeals have been settled in other Michigan counties with wind turbines Consumers, DTE
- 2. Nextera appealed the wind project in Gilford Townships (Tuscola Wind 1) based their appeal on the federal wind energy 1603 grant \$68 million federal grant
- 3. Interestingly Nextera did not appeal Tuscola Wind 2 in Fairgrove this project did not receive the federal cash called 1603 grants Nextera is hinging their Gilford appeal on 1603 grants
- 4. Nextera argues should reduce value because receive federal grant
- 5. Our lawyers disagree and remain optimistic will win case but a situation exactly like this has never been tested in the courts may take 2 years or more to play out MREC believe how it was finances has nothing to do with its true cash value
- 6. At this point our lawyers believe Nextera will proceed with their appeal to the Tax Tribunal and courts
- 7. Many other 1603 projects around the country but the federal program has now ended
- 8. Maybe we should ask federal officials to intervene and rule that the cash grants do not decrease the true cash value of wind projects

#### Commissioners

At the last Board meeting a request was made for a list of all county buildings and which departments are located in respective buildings along with the number of staff by building. (See attached list).

A few years ago major investments were made related to solving increasing county office space needs. Office space problems were solved by major remodeling in the Courthouse, FOC and Annex Buildings along with purchase of the Purdy Building. The county borrowed the funds to purchase the Purdy Building and still owes approximately \$900,000 in bond repayments. Other remodeling was accomplished through the expenditure of over \$600,000 from the capital improvement fund.

Several times in the past the public was asked for financial support to add on to the Courthouse to consolidate services. All of these requests were rejected.
