Vanderbilt Park Issues

I thought I would give you an update regarding some recent discussion by the Board of Commissioners regarding Vanderbilt Park. This matter was referred to the Parks and Recreation Commission for further discussion. Some of the questions and issues include:

- 1. Can the park attendant be certified to write tickets if parking fees are not paid
- 2. Prosecutor was requested to determine how parking fees can be enforced
- 3. Sheriff was asked if a police car could periodically drive through the park to help with parking enforcement and general security
- 4. Mike Miller (Buildings and Grounds) is looking into the cost of more and improved signs explaining parking fees
- 5. Commissioner Allen asked if signage for the park along M-25 could be improved and be in place in both directions of travel
- 6. Can the park attendant serve on the parks and recreation commission
- 7. Operational cost concerns if the park is upgraded with showers and other improvements
- 8. Meet with area townships and explore the potential of intergovernmental agreements to help finance park operational costs
- 9. Determine if grant funds will be pursued this decision may be tied to interest from area townships with joint financing
- 10. Land ownership remains a question this would need to be resolved before pursuing grants there is a park survey but the land ownership issues never seems to get resolved

The help of the Parks and Recreation Commission with these matters is appreciated.
