WHEREAS, this Board feels that landlines remain the best form of service for Antrim County and other rural communities; now

Outcomes for the Month:

- Jon Suber, started March 14, 2014 as the MIS Manager for both Huron and Tuscola County Health Departments.
- Bonnie Sammons, Fiscal Manager, is retiring on March 31, 2014. Debra Cook has started as Bonnie's replacement and is in the process of receiving orientation from Bonnie.

Issues under consideration by the Local Health Department:

- The need for Medicaid and affordable dental service continues. Tuscola County residents are calling every week for dental services. Some of these people have been calling for the past two years looking for affordable dental services and not all of them have Medicaid. Under the Medicaid expansion called Healthy Michigan Plan, more people will have dental coverage but they are still going to have a problem finding dental services. We are researching the development of a Public Health Dental Clinic under the Health Department umbrella. We visited VanBuren/Cass District Health Department on March 4th who has had a Public Health Dental Clinic for over 20 years. We are working on the model that would work in the Thumb. We will bring a proposal to the BOH and BOC as soon as we have all the details and numbers worked out. We are seeking grants to assist in the development of this Dental Clinic.
- The cases of reportable flu for Tuscola County are still at low levels. We still have vaccine available.
- Two bats were sent in for rabies testing. One bat tested negative and the
 other was untestable because of the extreme trauma to the bats brain.
- Our Auditor, Health Thomas presented the 2012/2013 audit findings to the Board of Commissioners on March 13, 2014.
