HUMAN DEVELOPMENT COMMISSION

A Proposal on Becoming an Outside Contractor for Tuscola County

Purpose of the Request

The Human Development Commission (HDC) offers free, confidential foreclosure prevention counseling for county residents who are facing (or threatened with) the loss of their single, largest asset – the family home – due to mortgage and/or property tax delinquency.

HDC is interested in creating a pilot project wherein the agency would become an outside contractor for Tuscola County to help homeowners, in particular land contract holders, avoid foreclosure due to delinquent property taxes. Between February 2013 and February 2014, HDC's foreclosure staff counseled 23 county residents who had delinquent property taxes. Two of the 23 (8.7%) were land contract holders.

How Funds Would Be Expended

HDC is interested in accessing funds from the county's *Delinquent Tax Property Sales Proceeds* account as payment for foreclosure prevention counseling. The county would be the "payer of last resort" after all other funding sources like the Michigan State Housing Development Authority and NeighborWorks are billed. It is HDC's experience that land contract holders with delinquent property taxes are the most challenging customers to obtain counseling funds for, as many funders do not consider these customers to be homeowners.

Foreclosure prevention counseling would include an assessment of the homeowner's financial capabilities and a review of options (e.g., Step Forward, The Michigan Hardest Hit Funds[®] Program; Poverty Exemption Letter to Township; etc.) to avoid foreclosure due to delinquent property taxes. Counseling services would also include referrals to other resource agencies that may help the homeowner with such needs as employment, health care, and nutrition.

Amount of Funds Requested

HDC requests financial consideration of \$2,000 - \$3,000 for calendar year 2015. This funding request would serve eight-to-twelve households, using "payer of last resort" funds.

Other Information

HDC is a HUD-approved Housing Counseling Agency that provides education and counseling services for homebuyers and homeowners in the "thumb" area. In addition, the agency has adopted the National Industry Standards for Homeownership Education and Counseling, which is a set of guidelines for quality homeownership and counseling services that includes a Foreclosure Intervention Specialty.

The early salt price increased from \$39.80/ton to \$63.31/ton (increase of 59%), and the backup salt price increased from \$40.98/ton to \$70.96/ton (increase of 73%). The Board will further discuss the Road Commission's winter maintenance operations and increased expenses.

Outcomes for the Month:

• We received a grant for the Children's Special Health Care Services program to promote the program and to include client input into program policies and procedures.

Issues under consideration by the Local Health Department:

- The FY14-15 Budgets are being submitted.
- The Health Department has offered five late clinics in the month of September. This is three additional evening clinics. This was done to assist parents in getting their children's immunizations up to date for school and to avoid children being suspended due to their immunization status.
- As of September 15, 2014, there are no reported confirmed cases of D68 in Michigan. D68 is a non-polio enterovirus and is thought to occur less commonly than infections with other enteroviruses. Hospitals in Missouri and Illinois are seeing more children that usual with severe respiratory illness possibly due to enterovirus D68. The Michigan Department of Community Health has put protocols in place for testing and those have been shared with our local hospitals and physicians. Symptoms include mild to severe respiratory illness. Transmission is thought to occur much like the common cold virus, by person to person when an infected person coughs, sneezes. An uninfected person can also get the virus by touching a contaminated surface. There is no treatment or vaccine at this time. Many infections will be mild and self-limited while some people may need to be hospitalized. Individuals can protect themselves by 1) washing their hands with soap and water for 20 seconds; 2) avoid touching their eyes, nose and mouth with unwashed hands; 3) avoid kissing, hugging and sharing cups or eating utensils with people who are sick; 4) disinfect frequently touched surfaces, such as toys and doorknobs, especially if someone is sick.
- The Health Department went live with an HL7 interface to the Michigan Care Improvement Registry.
