Greetings Mike:

I wanted to follow up with you on our conversation yesterday regarding service fees and processing fees.

As discussed, FOC is asking for a budget amendment where the processing fee revenues under line item 000-610-215 be eliminated. FOC believes that it's prudent to instead have these fees allocated to the 215 fund under line item 143-609-000. It is estimated that this would result in a change to the general fund revenue of approximately 5-6K annually. The county treasurer would not need to take any action to effectuate this change. Instead, the FOC would change the line item this money is sent to via MiCSES/MiSDU.

In 2010, the Legislature modified MCL 600.2538 and increased the fees. The fee structure is as follows:all payers who pay child support through the Michigan State Disbursement Unit (MiSDU) are assessed a \$3.50 per month fee. Of the \$3.50, MiSDU sends \$1 to the state to be deposited in the state court fund, \$0.25 is sent to the Attorney General, and \$2.25 is sent to the county treasurer. Per SCAO, amounts transmitted to the general fund should be used to fund the provisions of the Friend of the Court that are not reimbursable through the IV-D program. This essentially means that \$2.25 should be used to help fund parenting time and custody activity. This money CANNOT be used to fund child support related activity or we could risk running afoul of the above statute and/or federal regulations regarding grant funded program income.

For some reason, we (FOC/Tuscola County) have bifurcated the fees coming in to the county where \$2 is going to the 215 fund under line item 143-609-000 and \$0.25 is going to the general fund under line item 000-610-215. I'm asking that the \$0.25 also be sent to the 215 fund to help defray some of our parenting time and custody expenses (non-IV-D expenses).

Note that in a recent published opinion (11/10/15), *Trantham v. State Disbursement Unit*, No. 322289, the Court held that the \$3.50 charge doesn't violate due process or the taking clause but the \$0.25 allocated to the Attorney General is not a fee and instead a tax which could possibly violate the the Distinct Object Clause and the Title-Object Clause of the Michigan Constitution. The Court went on to say that the remainder \$3.25 is properly characterized as a fee since it goes to support the work of the Friend of the Court either directly or indirectly. Specifically, the Court discussed how the \$2.25 was directly used by counties to fund the parenting time and custody work the FOC performs.

With the above in mind, it seems most appropriate to have the full \$2.25 directed to the 215 fund rather than just \$2.00 so we can clearly demarcate its use for custody and parenting time related work. As such, Friend of the Court is asking that a budget amendment be made removing FOC processing fees from general fund revenues. If possible, I would like to move forward with this change as soon as possible.

WHEREAS, A growing number of communities are banning the use of popular sky lanterns over fears the floating fires could spark unintended blazes; and

WHEREAS, Sky lanterns, a balloon-shaped piece of paper that typically has a bamboo frame with a fuel pad at the bottom to provide lift, originated in China over 1,000 years ago and have become popular in the United States over the last 10-15 years; and

WHEREAS, Sky lanterns, while not classified as fireworks Michigan but rather as aerial candles, can pose a danger to humans, wildlife and livestock and can cause structure fires as their landing cannot be controlled; and

WHEREAS, The National Association of State Fire Marshals came out against the devices two years ago citing a sky lantern that landed at a plastic recycling plant causing \$9 million in damage; and

WHEREAS, California, Hawaii, Illinois, Maryland, Minnesota, New Hampshire, Oregon, South Carolina, Tennessee, Utah, Virginia and Washington have passed legislation making use of sky lanterns illegal and Michigan legislators are also considering taking action to ban the sky lanterns; Therefore, Be It

## RESOLUTION

BY: BAY COUNTY BOARD OF COMMISSIONERS

- WHEREAS, U.S. trade deals for the past 25 years have been corporate-driven incorporating rules that skew benefits to economic elites while requiring working families to bear the brunt of such policies; and
- WHEREAS, The growing trade deficits, driven by the North American Free Trade Agreement, China's accession to the World Trade organization, and the U.S.-Korea Free Trade Agreement, have displaced 700,000 jobs and 3.2 million jobs, and 75,000; and
- WHEREAS, U.S. employment in manufacturing dropped by 5 million from 2000 to 2015; and
- WHEREAS, Michigan's unemployment rate is 5.4% and Michigan's poverty rate is 17% which requires the expenditure of limited public funds to assist families in crisis; and
- WHEREAS, Jobs lost due to trade devastate families and entire communities and can permanently reduce lifetime earnings for hundreds of thousands of workers; and
- WHEREAS, The long decline of the American manufacturing base— exacerbated by bad trade policies that reward outsourcing—has undermined our economic security and poses a direct threat to our national security; and
- WHEREAS, The offshoring of manufacturing and service jobs deprives local and state governments of sorely needed revenues, jeopardizing the livelihoods of millions of public servants as well as construction workers whose jobs depend upon infrastructure building repair and maintenance; and
- WHEREAS, Under NAFTA-style trade rules, the U.S. annual trade deficit has increased dramatically from 70 billion in 1993, the year before NAFTA went into effect, to more than \$508 billion in 2014; and
- WHEREAS, The disproportionate voice of powerful global corporations in the formation of U.S. "Free trade" agreements has advanced an agenda that undermines the public interest and threatens democracy; and
- WHEREAS, NAFTA and all but two of the U.S. trade deals that followed it include special legal rights for foreign investors, known as "investor-to-state dispute settlement" or ISDS, that allow foreign firms to bypass state and federal courts to challenge state and local laws, regulations, and administrative and judicial decision in international tribunals; and
- WHEREAS, The Trans-Pacific Partnership (TPP) is likely to include provisions locking in monopoly protections for expensive specialty drugs called biologics and constrict the government's ability to limit spending on drugs, potentially increasing drug costs for the government and all Americans; and
- WHEREAS, Foreign investors already have used NAFTA's ISDA provisions to challenge decisions regarding local building permits, state bans on toxic chemicals and decisions of state courts; and
- WHEREAS, Promoting economic growth with equity in Michigan requires an approach that reforms the entire trade negotiation process to ensure that voices of workers, farmers, small businesses, families and communities are heard and their interests addressed; and

- WHEREAS, The Trans-Pacific Partnership (TPP) has been negotiated in secret, effectively shutting state and local governments out of the process, limiting our ability to influence its rules to ensure the people of Michigan can participate in the benefits of trade; and
- WHEREAS, Given the enactment of fast track trade negotiating authority, states and their citizens will have no opportunity to correct shortcomings in the TPP since its text will not be made public until it is final and no longer can be improved; and
- WHEREAS, Repeating old mistakes in negotiating new trade agreements such as the TPP represents a missed opportunity to strengthen our economy, reduce income inequality and promote sustainable growth; Therefore Be It
- RESOLVED That the Bay County Board of Commissioners calls upon our elected officials in the U.S. Senate and U.S. House of Representatives to oppose the TPP and any similar trade deals if they fail to restructure the misguided and failed policies of the past; Be It Finally

RESOLVED The Bay County Board of Commissioners calls upon our elected officials in the U.S. Senate and U.S. House of Representatives to support new trade deals such as the TPP only if they will:

- Exclude Investor-to-state dispute settlement (ISDS) and other provisions that favor foreign companies over domestic ones and undermine public choices;
- Ensure that countries cannot undercut U.S.-based producers with weaker labor and environmental laws and enforcement;
- Ensure that the U.S. will engage in robust enforcement of trade rules, including labor and environmental rules;

# 17-year-olds legislation has potential to seriously strain county budgets

Legislation that would treat 17-year-olds as juveniles rather than adults, placing new burdens on the juvenile justice system throughout the state, will undergo vetting by the House Criminal Justice Committee on Dec. 1. The <u>20-bill package</u> would change numerous statutes to define 17-year-old defendants as eligible for services in the juvenile justice system and prohibit their placement in the adult corrections system. Advocates say Michigan lags behind the rest of the country in our treatment of youthful offenders, and that we are one of only a handful of states who treat 17-year-olds as adults.

Counties throughout the state, though, have shared numerous concerns regarding this legislation.

Aside from the public safety issues raised by prosecutors and some sheriffs, major concerns center on the court systems that do not have the financial resources or capacity to handle this new population. MAC has engaged a number of county court systems in a survey to help estimate the cost of such a change statewide.

Also, without additional state funding, such a change may violate the Headlee Amendment and could not be absorbed in many areas in the state due to lack of programming and juvenile facility space. MAC will advocate for state support for any such large-scale change.

MAC will soon provide a resolution template for county boards on this topic.
