For the period beginning on January 1, of 2007 and continuing through December 31, 2011, shall Tuscola County be authorized to assess a monthly surcharge of up to 16% (not to exceed \$3.20) of the highest monthly flat rate for basic single party telephone service within the geographic boundaries of Tuscola County to exclusively finance the equipping and operating costs of the 911 emergency telephone answering and dispatch system within Tuscola County? This is a renewal of a previously voter-approved authorization that will expire before the effective date of this authorization.
