Tuscola County will be accepting bids on replacing the existing shingled roof and the installation of a new Metal Roof at the Sheriffs Mechanics garage at 420 Court St Caro MI 48723. The following specifications shall be considered in your bid:

- 1. Complete tear off of existing shingles, tar paper, flashing, etc...
- 2. Replacement of damaged roof sheeting, (if needed).
- 3. Roof is to be installed following all manufactures installation instructions.
- 4. Must use a synthetic underlayment (such as Gripright).
- 5. Sheeting shall be directly applied to roof deck, and use a vented ridge cap.
- 6. A minimum drip edge of 1 inch, and snow guards are to be installed on the parking lot side (North).
- 7. Expanding foam sealant (closer strips) shall be used on sidewalls and gable ends to seal gaps.
- 8. Finish is to be baked on (such as Kynar 500).
- 9. Roof shall have a minimum of 40 year warranty.
- 10. Finish shall also have a minimum 30 year warranty against fading and cracking.
- 11. Color samples to be provided by contractor.
- 12. Contractor is to provide all permits if needed.
- 13. Contractor is responsible for all clean up and removal roofing materials and debris.
- 14. Contractor must be licensed and must provide proof of Workmen Comp and Liability insurance.

Please provide a cost option for a Sanded Seam roof with your bid.

All work is to be performed by qualified personnel.
