Resolution to Open Boy Scout Road to One Lane As Soon As Possible

Resolution 2020-06

Whereas, Boy Scout Road in Indianfields Township has been closed to the public since the month of May in the year 2019; and

Whereas, Indianfields Township is responsible for the repair of this road, but has been held to the subjective standards of the Tuscola County Road Commission contractor, Spicer Group; and

Whereas, Indianfields Township Board has complied and agreed to be responsible for the cost to open this road to a long-term one lane road. Indianfields Township Supervisor, Ray Rendon, has met all county requirements; and

Whereas, the cost of improving and maintaining alternative routes of Albin and Boy Scout Roads to subpar standards has infuriated ALL of the residents in this geographic area that have been negatively affected by this fourteen month Boy Scout Road closure; and

Whereas, the safety of Tuscola County residents is decreased in the event of medical emergencies due to substantial increase of time and at times alternate roads that are not usable due to mud, rain and snow; and

Whereas, the Tuscola County Road Commission is in a dispute with a private landowner and the contractor Spicer Group is requiring barriers to be placed on the center line of the road and the road to be widened an additional two feet.

Therefore, Be It Resolved, that the Tuscola County Board of Commissioners demand that the Tuscola County Road Commission instructs the contractor Spicer Group to proceed to immediately have barriers placed two feet of center of road toward the Cass River so that this road can be open to one lane traffic as soon as possible; and

Be It Further Resolved, that the Road Commission Supervisor will be expected to report to the Tuscola County Board of Commissioners a monthly update on the progress of Boy Scout Road until it is opened to the public as a one lane road; and

Be It Further Resolved, that the Tuscola County Road Commission Board will continue to work with the Indianfields Township Board to permanently resolve the Boy Scout Road dispute with a private citizen and the legal ownership of right of way to Tuscola County and update the Tuscola County Board of Commissioners.

Motion by Commissioner Vaughan, seconded by Commissioner Jensen to adopt Resolution 2020-06. A roll call vote was taken. Motion carried with:
