Mike,

Due to the heavy rainfall and flooding conditions throughout the County, we are expecting a substantial hatch of mosquitoes in the next week.

This unfortunately will occur close to the holiday.

In trying to prepare for this I would ask for permission to increase the hours and shifts for the staff, including instating the Sunday Shift if needed.

I would also like to request the temporary hiring of Rich Colopy our previous Biologist, to assist in laboratory operations. This will allow for the major job of

sorting the mosquitoes to send to Michigan State for disease testing. I expect this to last for three to four weeks at most.

We have adequate funds in our budget to accommodate these changes.
