WHEREAS, every year on April 28th, communities and worksites around the world honor friends, family members, and colleagues who have been killed or injured on the job; and

WHEREAS, in 2021, The Federal Bureau of Labor Statistics estimated that 5,190 workers were killed by traumatic injuries on the job. On average, nearly 100 workers died every week, at roughly 14 workplace deaths a day; and

WHEREAS, in 2021, 140¹ workers were lost through fatal workplace accidents in Michigan; and

WHEREAS, it is appropriate to honor the memory of the courageous and dedicated members of Michigan's labor force who have been injured or disabled or have died as a result of workplace accidents; and

WHEREAS, we remember those who have died in workplace catastrophes, suffered occupational-related diseases, or have been injured due to dangerous conditions; and

Letter of Understanding Regarding FLSA Exemption

WHEREAS, the National Labor Relations Board (NLRB) has certified that the Police Officers Association of Michigan (POAM) is a bona fide representative, for purposes of Section 7(b) of the Fair Labor Standards Act (FLSA), of the employees of Tuscola County in the following bargaining unit:

All full-time and regular part-time employees working in E-911 Central Dispatch in the classification of telecommunicator; but excluding the Director, executive employees, supervisors, confidential employees, irregular employees, and all other employees."

WHEREAS this Letter of Understanding (LOU) constitutes an agreement made as a result of collective bargaining by representatives certified as bona fide by the NLRB under Section 7(b) of the FLSA for purposes of exempting bargaining unit employees from the overtime requirements set forth in Section 7(a) of the FLSA.

The parties hereby agree as follows:

- 1. For a consecutive 52-week period from the effective date of this LOU:
- (a) Full-time bargaining unit employees shall normally be scheduled to work two 12-hour shifts and one 8-hour shift (32 hours) in one workweek followed by four 12-hour shifts (48 hours) in the next workweek (or vice versa) for a total of 80 hours in a two-week pay period with this pattern repeating throughout the 52-week period of this LOU, subject to time off for vacation, personal leave or sick time. The Employer may change the work schedule whenever it determines operating conditions warrant such changes; provided, however, that before such changes are made a special conference will be requested.
- (b) During the 52-week period, employees shall be employed not more than 2,240 hours and shall be guaranteed at least 2,080 hours. Any hours paid for but not worked, such as vacation, personal leave or sick time, are not included in the 2,240 hour maximum but shall be included in determining whether the guaranteed hours have been met.
- (c) All hours worked in excess of 80 hours during a two-week pay period shall be paid at one and one-half times the employee's regular rate of pay.

TRAVEL/MEAL POLICY Revised 4/13/23

PURPOSE

The purpose of this policy is to establish guidelines to reimburse Tuscola County officials and employees for travel expenses incurred as a result of their official duties at rates established by the Board of Commissioners and in accordance with the specific provisions enumerated herein.

The policy shall apply to all officials and employees who by the nature of their assigned responsibilities, or because of special circumstances, are required by the County to use their privately-owned vehicle for travel and/or perform functions at a location other than their normal work location.

2. POLICY

- 2.1 Mileage. Mileage will be paid at the rate established by the Board of Commissioners to those officials and employees required to use their privately owned vehicle in conducting County business. The rate may be updated each year based on the Internal Revenue Service rate. The Board may choose to not increase the rate or fully/partially increase the rate to the IRS rate.
 - 2.1.1 When traveling to out-of-county activities, transportation must be shared whenever possible. Economical use of County funds has priority over personal convenience or preference.
 - 2.1.2 All mileage shall be computed from the normal work location to the destination point and return except in the following situations:
 - 2.1.2.1 Mileage will be computed from residence to destination if actual departure is from the residence and if the distance is less than the distance from work location to destination.
 - 2.1.2.2 If the distance is greater from the residence, the employee may still leave from there, but mileage will be calculated from the work location to destination.
 - 2.1.2.3 Under no circumstances is mileage allowed between residence and normal work location.

TRAVEL/MEAL POLICY

- 2.2 Meals. The standard meal rate \$36.00 per day as of 1-1-2018 will be Effective May 1, 2023 the standard meal rate of \$60.00 per day will be paid except when traveling to these certain metropolitan areas: All of Wayne and Oakland Counties, Ann Arbor, Auburn Hills, Detroit, Grand Rapids, Holland, Mackinac Island, Petoskey, Pontiac, South Haven, Traverse City and Leland. When traveling to these areas the standard meal rate per day as of 1-1-2018 will be paid at \$44.75. of \$75.00 per day will be paid effective May 1, 2023.
- 2.2.1 Official travel, which takes the individual outside the boundaries of Tuscola County during the entire mealtime hours, will render eligibility for a per diem meal allowance, based on when the employee was required to leave and return. Meal allowances are not cumulative from meal to meal or day to day. The Controller's Office shall publish from time to time the approved rates.
- 2.2.2 If all three meals (breakfast, lunch, and dinner) are provided by the conference or training session, then the employee is not eligible for a daily meal reimbursement from the County.
- 2.2.3 Alcoholic beverages are not eligible for reimbursement from the County.
- 2.2.4 Tips are limited to 20% of the total meal cost.
- ADD: 2.2.5 Delivery fees of up to \$10.00 are eligible for reimbursement from the County, where deemed appropriate by the Department Head.
 - 2.3 Accommodations. Reimbursement may be made for actual expenditures for overnight accommodations subject to the following restrictions and limitations:
 - 2.3.1 Overnight lodging expenses for County business will only be reimbursed if said event is 60 miles or more from the County complex in Caro, ADD: unless prior approval is obtained by the Board of Commissioners.
 - 2.3.2 Reimbursement is limited to the cost of a single room at prevailing rates for accommodations normally used in business; however:
 - 2.3.2.1 Double accommodation may be utilized when appropriate.
 - 2.3.2.2 If a "double" is shared with a County Official or Employee,

each may claim reimbursement for one-half (1/2) of the rate.

- 2.3.2.3 If the cost of a "double" is shared with a non-county employee, reimbursement may be claimed for the actual expenditure or an amount equal to the rate for a single occupancy accommodation, whichever is less.
- 2.4 Budget for Travel Related Expenses. Expenses associated with attendance at meetings, conferences, and seminars shall be requested by the Department Head during the preparation of the annual budget. Routine mileage allowance associated with day to day business within the County will be a separate line item.
 - 2.4.1 A written request for all out-of-state travel must be submitted to the Board of Commissioners for review and approval prior to attending. ADD: Out-of-state travel expenses incurred by Juvenile Probation employees to visit a juvenile placed out-of-state will not require prior Board of Commissioner approval; but approval by the Chief Judge and Court Administrator is required.
 - 2.4.2 Travel within the State requiring overnight stay will be allowed subject to approval of the Department Head and to availability of funds within the department budget. No additional funds will be transferred to the travel account after adoption of the budget, unless approved by the County Board of Commissioners.
 - 2.4.3 Travel within the State of Michigan for the purpose of transacting County business, i.e., meeting with State Officials or to discuss common concerns with other governmental officials will be allowed subject to approval of the responsible Department Head or Elected Official and no overnight stay is required.
- 2.5 Violation of Policy. If there is any infraction of this policy, no reimbursement of expenses will be allowed ADD: reimbursement from the employee will be required.
- 2.6 Preparation of the Travel Expense Voucher. The County Travel Expense Voucher must be completed within 30 Days after the conclusion of the event. Original Receipts must be attached to the travel voucher, copies will not be permitted. The receipt should have an itemized breakdown of all purchases at the dining establishments in order to receive reimbursement.

FY 2023 Per Diem Highlights

We establish the per diem rates for the continental United States (CONUS), which includes the 48 contiguous states and the District of Columbia. Federal agencies use the per diem rates to reimburse their employees for subsistence expenses incurred while on official travel.

Federal per diem reimbursement rates consist of a maximum lodging allowance component and a meals and incidental expenses (M&IE) component. Most of CONUS (approximately 2,600 counties) is covered by the standard per diem rate of \$157 (\$98 lodging, \$59 M&IE). In fiscal year (FY) 2023, there are 316 non-standard areas (NSAs) that have per diem rates higher than the standard rate.

Since FY 2005, we have based the maximum lodging allowances on average daily rate (ADR). ADR is a widely accepted lodging industry measure derived from a property's room rental revenue divided by the number of rooms rented. This calculation provides us with the average rate in an area. For more information about how lodging per diem rates are determined, visit <u>Factors Influencing Lodging Rates</u>.

We remind agencies that the Federal Travel Regulation (FTR) allows for actual expense reimbursement when per diem rates are insufficient to meet necessary expenses. Please see <u>FTR §301-11.300 through 306</u> for more information.

FY 2023 Results:

The standard CONUS lodging rate will increase from \$96 to \$98. All current NSAs will have lodging rates at or above FY 2022 rates. The M&IE per diem tiers for FY 2023 are unchanged at \$59-\$79, with the standard M&IE rate unchanged at \$59.

There are no new NSA locations this year. The following locations that were NSAs (or part of an established NSA) in FY 2022 will move into the standard CONUS rate category:

- Cromwell/Old Saybrook, CT (Middlesex County)
- El Paso, TX (El Paso County)
- Rock Springs, WY (Sweetwater County)

Legislative Conference begins 3-day run on Monday

Nearly 300 county leaders, policy experts and others will converge on Lansing on Monday for the start of the 2023 Michigan Counties Legislative Conference, the first major conference of MAC's 125th Anniversary year.



Attendees may check in for the conference starting at noon at the Radisson Hotel in downtown Lansing. Light snacks will be available in the registration area.

Policy breakouts get under way for MAC members at 2 p.m., with sessions on Michigan's trails system, the trial court funding crisis and the impact of electric vehicles on road funding in our state.

Plenary sessions on Tuesday and Wednesday will feature:

- Matthew Chase, CEO of the National Association of Counties
- · Chris Harkins, Michigan's state budget director
- · A legislative leadership panel

Commissioners attending the conference also will participate in MAC caucus elections on Tuesday to fill five seats on the MAC Board of Directors.

A Legislative Reception on Tuesday evening will feature the presentation of MAC's County Advocate Awards to Rep. Julie Rogers (D-Kalamazoo) and Sen. Jon Bumstead (R-Muskegon).

MAC-backed public notices bill filed in House

Legislation creating the framework to allow public bodies to post their notices digitally to save time and money is back before the Legislature.

Under <u>House Bill 4428</u>, by Rep. Kevin Coleman (D-Wayne), local units would no longer be required to post their notices in a newspaper but only share them online. This would modernize public notices law, save counties time and money and create more avenues for our citizens to receive public notices.



HB 4428 is identical to a bill he sponsored last term that was not enacted. MAC supported this legislation the last time around, with MAC's Deena Bosworth testifying before the House Oversight Committee on its behalf.

The Michigan Press Association has long opposed this concept because its members rely on the fees they charge locals for publishing such notices.

This bill is just the first of more than 100 bills that will be necessary to implement the change. HB 4428 will serve as the framework, while the trailer bills will amend each statute requiring the notice to be published in a newspaper.

HB 4428 has been referred to the House Committee on Local Government and Municipal Finance. **MAC** plans to support the bill.

Legislative panels cut governor's request on indigent defense

There would be fewer dollars for the Michigan Indigent Defense Commission (MIDC) in fiscal 2024 than the governor has requested under spending plans approved by House and Senate subcommittees this week.

Gov. Gretchen Whitmer's Executive Budget included a \$72 million increase to MIDC grant funding as a response to the state's approval of Standard 8, the Attorney Compensation Standard. However, the subcommittees rejected this approach.



<u>House Bill 4280</u> includes a \$57.2 million increase, totaling their MIDC budget to \$206 million. <u>Senate Bill 195</u> includes a \$59 million increase, totaling the Senate version of the MIDC budget to \$208.7 million. The governor's recommended full funding for MIDC is \$220 million.

The MIDC grant funding that is allocated to counties, so long as they comply with the state-approved Standards 1-8.

MAC is continuously working to ensure the state provides full funding to counties via MIDC grant dollars, as they are mandated to do. While it is still early in the budget process, and there is potential for the MIDC appropriation to increase, it is important to note that without full funding provided by the state, counties are not mandated to comply with Standard 8.

Financial strains on legal staffing are subject of special podcast episode

The pair talked about their experience on the commission, which "was created by legislation in 2013 after an advisory commission recommended improvements to the state's legal system. The MIDC works to ensure the state's public defense system is fair, cost-effective and constitutional while simultaneously protecting public safety and accountability," and the importance of its work.

Gibson reviewed the of MIDC's new standard 8 on prosecuting attorney offices and staffing.

 planning process undertaken by the county. This document is also intended to inform the community
 of anticipated stakeholder engagement and request for proposals processes.

Environmental spending plans head in different directions

Subcommittees in the Michigan House and Senate this week took notably different avenues on plans for water infrastructure and other items advanced by Gov. Gretchen Whitmer in her fiscal 2024 budget.

The House Appropriations Environment, Great Lakes and Energy Subcommittee got creative, recommending \$100 million more than the governor did by replacing hundreds of millions in state General Fund dollars with federal funding.



Most notably, the governor proposed \$225.8 million in General Fund for replacing lead service lines and providing technical assistance to communities, but the House reduced that amount to \$110 million, supplemented by \$100 million in federal Coronavirus State Fiscal Recovery Fund dollars.

Also from the Coronavirus State Fiscal Recovery Fund, the House EGLE subcommittee recommended new line items for drinking water asset management, drinking water filtration devices in schools and child-care centers and infrastructure improvement projects for drinking water, storm water and wastewater.

By contrast, the Senate Appropriations Environment, Great Lakes and Energy Subcommittee reduced the governor's original proposal from \$1.3 billion to \$1.08 billion. The main reductions came from her recommendations for regional renewable energy facilities, groundwater data collection and contaminated site clean-up.

The subcommittee chairs will meet shortly to concur on one version. The budget must be finalized before the end of June, though legislators can finish earlier.

Senate Democrats introduce renewable power bills

Michigan utilities would have to produce 100 percent of their electricity from renewable sources under legislation introduced in Lansing this week.

To achieve this, the seven-bill package, <u>Senate Bills 271-277</u>, would also eliminate coal-fired electricity-generating plants by 2030. Sens. Sam Singh (D-Ingham) and Sue Shink (D-Washtenaw) are leading the efforts to eradicate all greenhouse gas emissions from power generation as part of the <u>Clean Energy Future Plan</u>.

The bills also make the Michigan Public Service Commission will be responsible for evaluating the utility's integrated resources plan. Their plans must demonstrate progress toward phasing out greenhouse gases, eliminating adverse effects on human health and reducing harm to the health, safety, and welfare of communities subject to environmental injustice.



Other provisions in the package include:

- reducing carbon intensity of transportation fuels by 25 percent by 2035;
- creating a Michigan Construction Decarbonization Strategic Plan to reduce emissions from heating homes and businesses by 17 percent by 2030; and
- allowing farmers in the state's PA 116 program to preserve farmland to rent their properties for solar operations and stay in the preservation program.

While this may appear a massive undertaking, Consumers Energy already has announced a plan to eliminate coal in its operations by 2025.

The bills have been referred to the Senate Committee on Energy and Environment. **MAC** has not taken a position on the legislation.

Bill would restore local control over plastic bag regulations

Local control over the retail use of plastic bags would be restored under a bill introduced in March.

Senate Bill 228, by Sen. Sue Shink (D-Washtenaw), would allow local governments to determine whether to allow plastic bags in their communities. The legislation stems from concerns over the impact plastic bags can have on our environment, as they tend to end up as litter or non-recycled waste. SB 228 will grant locals the authority to weigh the environmental impacts and regulate their use as they see fit.



Banning plastic bags outright is not the only option permitted in this bill; locals could impose a fee or tax for using them.

SB 228 would reverse the state restrictions on local action adopted in Public Act PA 389 of 2016 signed by Gov. Rick Snyder.

Several states currently allow municipalities to regulate bag use, and major cities such as Chicago, Boston and Los Angeles have plastic bag bans on the books. Eight states have statewide bans: California, Connecticut, Delaware, Hawaii, Maine, New York, Oregon and Vermont.

The bill was sent to the Senate Committee on Energy and Environment. **MAC** has not yet taken a position on this legislation.

State offers grants for town halls on mental health, substance use issues

Throughout the COVID-19 pandemic, concerns about substance use and mental health conditions have grown.

The Michigan Department of Health and Human Services' (MDHHS) Substance Use, Gambling and Epidemiology Section (SUGE) is seeking applications from organizations to conduct Community Town Hall meetings that:

- Address the impact of this public health crisis on populations, especially disparate or underserved populations.
- Help raise awareness about coping with COVID-19 by sharing informational materials based on the latest research.
- Determine community concerns and disseminate relevant resources to address priority areas: underage drinking, marijuana, prescription drugs/opioids, tobacco and mental health.



The Community Town Hall must occur on or before Aug. 31, 2023.

- Applications will be accepted through <u>May 31, 2023</u>, on a first-come, first-served basis.
- Limited to 75 organizations.
- \$1,500 per Community Town Hall. You will be reimbursed for actual costs up to \$1,500 through a contract with our training logistics contractor: Community Mental Health Association of Michigan (CMHAM).
- MDHHS has the ability to deny an organization's application.

Funding can be used for expenses such as:

- Speakers
- · Panel discussions
- Venues
- · Evaluation efforts
- Technology (if applicable)

Funding cannot be used for:

- Promotional items, including but not limited to clothing, commemorative items such as pens, mugs/cups, folders/folios, lanyards, and conference bags.
- Direct payments to individuals to participate in prevention services. Note: Prevention provider may provide up to \$30 non-cash incentive to participate in data collection follow-up.
- · Meals are generally unallowable.

ONTONAGON COUNTY RESOLUTION 2023-09
AFFIRMING SUPPORT OF ALL CONSTITUTIONAL RIGHTS
INCLUDING, BUT NOT LIMITED TO,
THE RIGHT OF THE PEOPLE TO BEAR ARMS
AND TO ADEQUATELY FUND MENTAL HEALTH SERVICES

WHEREAS all elected county and state office holders take an oath of office under which the office holder supports the Constitution of the United States of America and Constitution of Michigan and to faithfully discharge the duties of such offices;

WHEREAS the issue of constitutional rights, including but not limited to, the Second Amendment to the Constitution of the United States of America has been in the spotlight of public discussion of recent;

WHEREAS public discussion of such constitutional rights is a hallmark of public discourse in a democracy;

WHEREAS the lawful ownership, possession and use of firearms is part of the cultural heritage within Ontonagon County, Michigan;

WHEREAS it is common for firearms to be family heirlooms that pass from generation to generation as a permanent connection of the past to the present within extended families;

WHEREAS recent high-profile firearm shootings have involved individuals that have mental health issues that the mental health systems nationwide failed to timely, appropriately, and adequately address; and

WHEREAS funding for mental health services in the State of Michigan is woefully underfunded, resulting in the failure to adequately provide services to persons of the State of Michigan that need mental health services.

NOW THEREFORE BE IT RESOLVED that the Ontonagon County Board of Commissioners supports and will continue to honor the pledge to support the Constitution of the United States of America as well as the Constitution of the State of Michigan, including all amendments thereto:

BE IT FURTHER RESOLVED that the Ontonagon County Board of Commissioners direct our legislators whom act as representatives of the People of the State of Michigan to:

- A. Not undertake legislation that is in conflict with the Second Amendment to the United States of America and Article 1 sec. 6 of the Michigan Constitution of 1963, including:
 - 1. Red Flag Laws, excluding the current Personal Protection Order process;
 - 2. Registration requirements of full or long firearms;
 - Mandatory storage schemes for firearms;
 - 4. Additional limitations on the lawful ownership and use of firearms; and
 - Adoption of other schemes of regulation of firearms that infringe on the foregoing constitutional guarantees of the People of the State of Michigan.
- B. Adhere to their oath of office and not adopt legislation, ruses, regulations and/or requirements that conflict with the Second Amendment to the Constitution of the United States and Article 1 sec. 6 of the Michigan Constitution and any final judicial determinations thereto:
- C. Adequately fund mental health services available in all our communities to provide for timely intervention with appropriate and adequate mental health services as an investment in the human capital of all persons of the State of Michigan; and

D. Insure that the providing of adequately funded mental health services is accomplished by methods that do not infringe on the statutory and constitutional rights of those in need of mental health services.

BE IT FURTHER RESOLVED that if in exercise of discretion by the Office of Sheriff and Office of Prosecuting Attorney both of the County of Ontonagon, determine that a law has been adopted which violates the Constitution of the United States of America, the Constitution of the State of Michigan, and any final judicial determinations thereto, that the Ontonagon County Board of Commissioners supports the lawful exercise of discretion not to enforce an unconstitutional law against any law abiding person within the County of Ontonagon;

BE IT FURTHER RESOLVED, that the Ontonagon County Clerk shall provide a copy of this Resolution to:

- A. Each township in the County of Ontonagon;
- B. Each county in the State of Michigan
- C. The Michigan House of Representative;
- D. The Michigan Senate;
- E. The Governor of the State of Michigan;
- F. Each United States Senator for the State of Michigan; and
- G. Each United States Congressman for the State of Michigan
