#### **Project Narrative**

The Tuscola County Sheriff's Office is a full-service organization to the residents of Tuscola County. It provides a road patrol, Correctional Facility, Marine patrol, Victim Services, and other activities.

Geographically, Tuscola County encompasses approximately 816 Square miles and borders Saginaw Bay, which is a part of Lake Huron. Lake Huron is a Great Lake which borders Canada.

Tuscola County provides a Marine Patrol for Saginaw Bay. Besides routine patrols for safety violations, by State Constitution the County Sheriff is responsible for body recover in its waters of jurisdiction.

Saginaw Bay is known nationwide for its Walleye fishery, both in the summer and winter. It attracts many local resident fisherman and also fishermen from across the country.

Because of its geographic location Saginaw Bay's waters can turn dangerous very quickly.

The vessel which is used for patrol on the bay is a 1999 Aqua Sport. It was purchased in that year and was designed to be a fishing boat. Over the years wear and tear on the boat has proven it is inadequate for routine patrolling and search and rescue.

A local diver group which worked with the Sheriff has submitted a letter that due to the vessels structure it is inadequate for transporting and supporting divers and is such dangerous.

In 2021 Sheriff Skrent approached the Tuscola County Board of Commissioners with this information however funding was not available to assist in the purchase.

The Tuscola County Sheriff's Office road patrol is funded by a millage, which is worded as such no money can be used to purchase a boat, as dictated by attorneys who have examined the millage wording. Therefore, the funding will have to come from the counties general fund money.

On April 24<sup>th</sup>, 2023 Sheriff Skrent approached the board again and provided them with a possible selection of a new vessel and repeated the reasons why the Sheriff needs a modern boat, designed for patrol and search and rescue. The board is receptive to seeking the funding to purchase a new patrol boat.

There are hundreds of established legal lake levels throughout Michigan under Part 307. Based on my understanding, many (if not most) lake level court orders (like Shay Lake's) establish lake levels simply using a single elevation (or multiple elevations for lakes with winter and summer levels). As you may know, an inland lake's level will slightly fluctuate even with an established lake level and lake level control structure. Fluctuations from an established lake level elevation can be caused by weather or natural events or the operation of a lake level control structure with the intent to maintain a lake level elevation (e.g., water banking).

In 2022, the Michigan Court of Appeals in litigation involving Higgins Lake narrowly interpreted Part 307. See *Citizens for Higgins Lake Legal Levels v Roscommon County Board of Commissioners*, 341 Mich App 161 (2022). The Court generally found that counties must maintain established lake levels at all times at exact lake level elevations set forth in a lake level order. That is problematic for Shay Lake and most established lake levels in Michigan because it is generally impossible to not have even slight lake level variations.

To protect property owners in the district from similar legal challenges like the *Higgins Lake* case (that can impose financial liability to the district), I am recommending making a minor change in circuit court to the lake's lake level order to specify that the legal levels of Shay Lake may reasonably fluctuate based on weather, construction, and lake level infrastructure operations. However, please know it is our office's continued intent to best maintain the levels of the lake using the existing lake level infrastructure.

I hope this explains why my office intends to amend the Shay Lake – lake level order with respect to lake level elevation fluctuations. Again, the intent of this amendment is to protect the district and property owners and not to change how the level of the lake is maintained.

## County revenue sharing in line for big boost under budget plans

County revenue sharing could grow by as much as 17 percent in fiscal 2024 under decisions made this week by key subcommittees in the Michigan House and Senate.

In the House, the Appropriations Subcommittee on the General Government approved <u>House Bill 4292</u>, by Rep. Felicia Brabec (D-Washtenaw), which follows Gov. Gretchen Whitmer's plan for a 17 percent hike in revenue sharing.



This increase is divided into several segments:

- 5 percentage points would be ongoing and for general use
- 5 percentage points would be a one-time appropriation for general use
- · 2 percentage points would be ongoing and restricted to public safety uses
- 5 percentage points would be a one-time appropriation restricted to public safety uses

In all, these changes would place FY24 revenue sharing at more than \$285 million.

The Senate's boost is smaller than the House's but still large. <u>Senate Bill 189</u>, by Sen. John Cherry (D-Genesee), includes the same ongoing and one-time boosts for general use as the House (see bullets 1 and 2 above), but it does not include the additional funds for public safety.

Overall, the Senate's plan would have revenue sharing at \$269 million for FY24.

In another positive note, and based on a MAC request, the Senate subcommittee plan would end the County Incentive Program and its requirements for the annual submission of verification of the posting of budgets online and the publication of citizen guides.

The Senate proposal also allows access to any unallocated funds from a \$750 million appropriation for municipal pension assistance for use as grants for those local governments with OPEB obligations funded at 7 percent or less. An exact allocation for this will not be known until pension grants have been allocated.

Finally, on the Senate side, Sen. Cherry recommended a new program in the Department of Attorney General to assist communities with high crime by allocating \$10 million and 45 full-time positions.

To be clear, these amounts are far from final. The next huge budget step is the Consensus Revenue Estimating Conference (CREC) on May 19 to set final resource numbers for FY24. Following CREC, committee chairs will be given more specific budget targets and will amend the bills accordingly.

## Child Care Fund boost highlights DHHS budget plans

A MAC-supported increase in the reimbursement rate for the Child Care Fund is included in both legislative versions of the fiscal 2024 budget for the Department of Health and Human Services that cleared key subcommittees this week.

In line with a recommendation of the Task Force on Juvenile Justice Reform, the budget plans boost the county Child Care Fund reimbursement rate from 50 percent to 75 percent, a \$31.5 million increase. This conforms with Gov. Gretchen Whitmer's FY24 budget plan.



#### The <u>House subcommittee also recommended</u>:

- \$1.3 million to provide services at Bay Pines and Shawono juvenile justices facilities (another recommendation from the Task Force on Juvenile Justice Reform)
- \$19.3 million to fund an 8 percent increase to daily maintenance payments to foster parents, adoptive parents and juvenile guardians (a MAC legislative priority)
- Placing Michigan's foster care per diem rate above the national average
- \$25 million to build a juvenile justice facility in Northern Michigan (another MAC priority)
- \$14 million for the state share towards local public health departments

• \$5 million to replace local funding used for Medicaid mental health supports and services (this reflects the fourth year of phasing out the local match portion over a five-year period)

The <u>Senate recommendation</u> includes \$30 million to support the state share for increases to local public health departments, which aligns with the governor's budget plan. When compared to the House recommendation, you will see the House has only recommended funding for approximately 50 percent of the costs of local public health services.

## Legislative panels add dollars to governor's transportation plans

Road dollars in fiscal 2024 would be more plentiful than Gov. Gretchen Whitmer had proposed in February under spending plans approved by House and Senate subcommittees this week.

Both chambers appropriated more than Whitmer recommended; the <u>House version</u> is \$222.6 million over, while the <u>Senate's</u> is \$240 million over.



The largest addition by the House is \$400 million for local road preservation, which would be distributed to local road agencies based on population. The House left a \$100 placeholder for the bridge bundling program, so the \$200 million the governor had recommended was not included in the House plan.

The House also included:

- \$75 million in local bus operating investments
- \$33 million for rail grade separations

The Senate also cut the governor's bridge bundling program, reducing it from \$200 million to \$150 million. They also cut the Intermodal Capital Investment Grant Program from \$160 million to \$100 million.

Notably, the Senate added \$150 million for local road funding projects for the six most populous counties (Wayne, Oakland, Macomb, Kent, Genesee, Washtenaw), distributed by population. Subcommittee Chair Sen. Veronica Klinefelt (D-Macomb) explained that while the larger counties pay more into the Michigan Transportation Fund, they don't always see the return on investment.

The Senate also included:

- \$100 million for critical infrastructure projects
- \$100 million for high-speed rail
- \$50 million for a single rail grade separation project in Trenton

The budget process will continue in May. MAC will provide updates as necessary.

# Pay boosts for medical workers advance in Legislature

Employees at medical care facilities would be looking at pay boosts under budget plans approved by Health and Human Services Appropriations subcommittees for fiscal 2024 this week.

The <u>Senate recommendation</u> includes a 65-cent boost per hour for direct care workers and a \$3 per hour wage increase for non-direct care staff at long-term care facilities. The <u>House recommendation</u> includes \$90 million to increase non-clinical nursing facility staff hourly wages by \$3.85 per hour. This amount would reflect the current \$2.35 direct care wage increase, plus the additional \$1.50 proposed for the current cohort of direct care workers. The House budget recommendation also included a \$1.50 per hour direct care worker wage increase.



The FY24 budget is anticipated to be finalized in June.

# Bid to expand binding arbitration resumes in Legislature

County correctional officers would qualify for binding arbitration under a bill filed in Lansing on April 20.

<u>House Bill 4438</u>, by Rep. Kelly Breen (D-Oakland), would expand binding arbitration beyond police and fire labor bargaining units to county correctional officers. The bill is likely to advance in the Legislature this year.



HB 4438 is a reintroduction from last term, which MAC fought against. MAC has long opposed any expansion of binding arbitration

to other bargaining units due to the cost of the process, the long-term liabilities associated with third-party decisions and the unequal treatment such a system provides to those bargaining units. The Michigan Public Employment Relations Act already provides for bargaining rights without tying the hands of the county in binding arbitration.

## MAC plans to continue opposition to the bill.

However, in light of the legislative majority's strong support for unions and collective bargaining units, it will certainly be more difficult to shut it down this time around. The bill has been referred to the House Committee on Criminal Justice.

# Boat wrap recycling program now under way

The Michigan Recycling Coalition (MRC), a statewide recycling advocate and association, is currently organizing another year of "Recycle Run," a boat shrink-wrap recycling program. Last year alone, the program helped recycle 90,000 pounds of plastic.

The program is open and accepting new participants until June 1, 2023. Recycle Run is accessible to boaters across the state and allows for shrink-wrap boat covers to be diverted from landfills.



To participate, boaters purchase the Recycle Run bags from <u>Dr. Shrink's website</u> for \$7. A bag holds approximately one large boat cover or two small boat covers. Interested participants will also sign up on the <u>Michigan Recycling Coalition's website</u> to officially register for the collection program. Participants with more than 15 bags of material qualify for a free direct pick-up by the MRC's program partners. Participants with less material can participate by dropping their bags off at one of the many volunteer locations around the state. These boat covers are otherwise not accepted in curbside recycling programs.

Michigan has more than 800,000 registered boats. For every bag of covers that is recycled, we save:


- 115 KWH of energy
- · 5 gallons of oil
- 20 cubic feet of landfill space

## Resolution to Instruct our Representatives to Oppose All Firearms Control Legislation

WHEREAS, the Constitution of the United States, ratified on the 21<sup>st</sup> day of June, 1788, declares in Article VI section 2, "This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.";

WHEREAS, the people of the United States are guaranteed the right to keep and bear arms without any legislative infringement, under the Constitutional authority of Amendment II, "A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.";

WHEREAS, the people of the State of Michigan recognize that the blessings of freedom come from our Almighty God according to the Preamble of the Constitution of the State of Michigan, "We, the people of the State of Michigan, grateful to Almighty God for the blessings of freedom, and earnestly desiring to secure these blessings undiminished to ourselves and our posterity, do ordain and establish this constitution.";

WHEREAS, the people of the State of Michigan have the inherent, inalienable right to hold all political power in the State of Michigan according to the Constitution of the State of Michigan, Article I, Section 1. "All political power is inherent in the people. Government is instituted for their equal benefit, security, and protection.";

WHEREAS, the people of Michigan are guaranteed the right to keep and bear arms without any legislative infringement, under Michigan State Constitutional authority in Article I section 6, "Every person has a right to keep and bear arms for the defense of himself and the state.";

WHEREAS, the people of the State of Michigan recognize that we have the right to retain rights that are not specifically written in the Constitution of the United States or the Constitution of the State of Michigan according to: Amendment IX of the Constitution of the United States, "The enumeration in the Constitution of certain rights, shall not be construed to deny or disparage others retained by the people." and Amendment I, Section 23 of the Constitution of the State of Michigan, "The enumeration in this constitution of certain rights shall not be construed to deny or disparage others retained by the people."; and

WHEREAS, the people of the State of Michigan recognize that we have the right to instruct our representatives according to the Constitution of the State of Michigan, Article I, Section 3, "The people have the right peaceably to assemble, to consult for the common good, to instruct their representatives and to petition the government for redress of grievances."

## NOW, THEREFORE, BE IT:

**RESOLVED,** that the Alger County Board of Commissioners, as people of the State of Michigan, instruct our representatives of the 102<sup>nd</sup> Michigan State Legislature to vote in opposition of all proposed legislation that would unconstitutionally infringe on the right of the people to keep and bear arms;

# RESOLUTION DECLARING ALGER COUNTY, A CONSTITUTIONAL SECOND AMENDMENT SANCTUARY COUNTY

WHEREAS, the County Board of Commissioners of the County of ALGER, State of Michigan, pursuant to Michigan statute, (Article 7 Section 2 MC) is vested with the authority of administering the affairs of the County government of ALGER County, Michigan, (Article 7 Section 1 MC) and is organized as a body corporate with powers and immunities provided by law, (Article 4 section 51 MC) and to protect the health, safety, and welfare of the residents of ALGER County and the employees of the ALGER County government; and

WHEREAS, a statute by a legislative authority (Alger County Commissioners) is considered constitutionally valid until a court decides it's not; and

WHEREAS, the Second Amendment to The Constitution of the United States of America, ratified in 1791 as part of the Bill of Rights, states "A well-regulated Militia, being necessary to the security of a free state, the right of the people to keep and bear arms shall not be infringed"; and

WHEREAS, the United States Supreme Court in United States v. Miller, 307 U.S. 174 (1939), opined that possession or use of a firearm that has some reasonable relationship to the preservation of a well-regulated militia is protected by the Second Amendment; and

WHEREAS, the United States Supreme Court in District of Columbia v. Heller, 554 U.S.570 (2008), affirmed an individual's right to possess a firearm, unconnected with service in a militia, and to use that firearm for traditionally lawful purposes, such as self-defense within the home; and

WHEREAS, the United States Supreme Court in McDonald v. Chicago, 561 U.S. 742 (2010), affirmed that the right of an individual to "keep and bear arms," as protected under the Second Amendment, is incorporated to the States by the Due Process Clause of the Fourteenth Amendment; and

WHEREAS, Article I, Section 6 of the Michigan Constitution (1963) provides that "Every person has a right to keep and bear arms for the defense of himself and the state"; and

WHEREAS, it is the desire of this Board to reaffirm its commitment and support of The Constitution of the United States of America as well as the Constitution of the State of Michigan including all amendments which protect Alger County citizens' individual rights; and

WHEREAS, it is the desire of this Board to declare its support of the Second Amendment to the United States Constitution and to the provisions of the Michigan Constitution which protect ALGER County citizens' individual rights to keep and bear arms; and

WHEREAS, each Alger County Commissioner, as provided by Article IX, section 1, of the Michigan Constitution (1963), took an oath to support The Constitution of the United States of America and the Michigan Constitution.

WHEREAS, a "Constitutional Sanctuary County" is defined as a place of refuge for the law abiding citizen in regards to the citizens' rights under The Constitution of the United States of America and Michigan Constitution including but not limited to the Second Amendment right to Keep and Bear Arms.

NOW THEREFORE IT IS HEREBY RESOLVED, by the ALGER County Board of Commissioners, that the County of ALGER, Michigan, be, and hereby is, declared to be a "Constitutional Sanctuary County."

IT IS FURTHER RESOLVED, that this Board affirms its support for the Alger County Sheriff and the Alger County Prosecuting Attorney, in the exercise of their sound discretion to NOT enforce any statute or law that is contrary to the rights established by The Constitution of the United States of America and the State of Michigan constitution against any law-abiding citizen of Alger.

BE IT FURTHER RESOLVED, that this Board will not authorize or appropriate funds, resources, employees, agencies, contractors, buildings, detention centers or offices for the purposes of enforcing any law that restricts the rights of any law abiding citizen affirmed by the Second Amendment or Article 1, Section 6, of the Michigan Constitution, nor be used to aid any state or federal agency in infringing or restricting such rights which would be considered to be unconstitutional; and

BE IT FURTHER RESOLVED, that the Board respectfully requests the Michigan Legislature, the United States congress and other agencies of State and Federal government to vigilantly preserve and protect those rights by rejecting any provision, law or regulation that may infringe, have the tendency to infringe or place any additional burdens on the rights of law-abiding citizens to keep and bear arms; and

BE IT FURTHER RESOLVED, that the Board directs its staff to forward a copy of this resolution to the Alger County Township Supervisors, Alger County elected officials, and the other 82 counties in the State of Michigan, the Michigan State Legislature (House of Representatives and State Senators), the Governor of Michigan and all of the Michigan U.S. Congress members.

## **RESOLUTION #2023-09** RESOLUTION SUPPORTING DARK STORE LEGISLATION

WHEREAS, Representative of Michigan's 38th Senate District, Senator Ed McBroom, seeks to introduce two bills, Senate Bill Numbers 19 and 20, intended to address the method by which the Michigan Tax Tribunal values certain properties, including big box and junior box stores, commonly referred to as the "Dark Store" theory of value; and

WHEREAS, the Tax Tribunal, on numerous occasions, has valued such properties through comparisons to sales of other big box or junior box stores that have "gone dark," i.e., have failed to produce retail sales due to their location in the market; and

WHEREAS, the Tax Tribunal has also valued box stores by comparisons to sales of other box stores that were sold with a private deed restriction in place, which precluded the use of the sold box store for use as a box store; and

WHEREAS, these Tax Tribunal decisions across the state have resulted in artificially reduced values for thriving box stores due to comparisons to stores that either failed or were sold for some other secondary purpose, such as redevelopment for some other commercial use; and

WHEREAS, in Alger County the application of the "Dark Store" method has led to the reduction of public library hours and negatively impacted the County's General Fund balance, leading to reduced funding for County programs; and

WHEREAS, the legislation seeks to remedy these issues by requiring the Tax Tribunal to assure that box stores are valued according to their "highest and best use" by excluding the use of sale comparables sold with private restrictions in place if those restrictions substantially impair the comparable's highest and best use as compared to the property being valued; and

WHEREAS, the legislation seeks to require the use of sale comparables that are adequately comparable to the property being valued.

**THEREFORE**, the Board of Commissioners of Alger County, Michigan, resolves as follows:

- 1. The Alger County Board of Commissioners hereby supports the legislation to be introduced by Senator McBroom, Senate Bill Numbers 19 and 20.
- 2. Any resolutions that are inconsistent with this Resolution are hereby repealed to the extent necessary to give this Resolution full force and effect.
