RE: CONCRETE WORK

Tuscola County will be accepting bids on the installation of a concrete driveway at the Tuscola County Recycling Center 1123 Mertz Rd (M-24) Caro MI 48723. The following specifications shall be considered in your bid:

1. Contractor is to follow all local, State, and Federal building codes.
2. Contractor is responsible for any needed drawings and permits.
3. Contractor shall excavate existing gravel and soil down to a minimum of 14 inches.
4. Contractor is to reuse existing gravel to provide a base of 6 inches, or sand may be used instead, but contractor is to bid it as a separate option. Base shall be compacted.
5. Tuscola County Recycling will retain any excavated material not reused in the project.
6. Contractor is to provide a final grade that sheds water away from the main building.
7. Contractor is to install a wire mesh (6 inch squares).
8. Contractor is to pour 8 inches of concrete as Recycling has semi truck traffic weekly. Expansion joints are to be used where needed.
9. Contractor shall back fill new concrete pad as need, to prevent damage.
10. Concrete drive will begin at the shoulder of the road and end approximately 123 feet at the main buildings north overhead door and be approximately 21 feet wide. Contractor shall verify all measurements before bidding.
11. Project is be completed by June 15th, 2012. Contractor shall work with the Director on project dates.
12. Contractor shall provide all necessary barricades; to prevent damage to new concrete during process.
13. Contractor shall be responsible for repairing any damage to the landscaping.
14. All work shall be performed by qualified personnel.
15. Contractor shall be insured and provides copies of Work comp. and Liability before work begins.

Closed sealed proposals shall be submitted to the Tuscola County Recycling Center at 1123 Mertz rd Caro Michigan 48723 no later than 4:30 pm on March 12th, 2012.
