Tuscola County Resolution No. 2026-07

WHEREAS, Section 6(4) of the County Road Law, MCL 224.6(4), provides that a county board of commissioners with an elected board of county road commissioners may transfer the powers, duties, and functions of the elected board of county road commissioners to an appointed board of county road commissioners if both of the following occur: (a) the board of commissioners submits that question to the qualified and registered electors of the county at the next regular election to be held in the county; and (b) a majority of the qualified and registered electors of the county voting on the question vote in favor of transferring the powers, duties, and functions of the elected board of county road commissioners to an appointed board of county road commissioners.

WHEREAS, the Tuscola County Board of Commissioners wishes to submit to the qualified and registered electors of Tuscola County the question of whether to transfer the powers, duties, and functions of the elected Board of Tuscola County Road Commissioners to an appointed Board of Tuscola County Road Commissioners.

NOW THEREFORE, BE IT RESOLVED that the Tuscola County Board of Commissioners approves the following ballot question language to be submitted to the qualified and registered electors of Tuscola County and directs the Tuscola County Clerk to submit the ballot question to be placed on the August 4, 2026 election ballot:

TUSCOLA COUNTY

Transfer of Powers, Duties and Functions of Elected Board of County Road Commissioners to Appointed Board of County Road Commissioners

Shall the powers, duties and functions of the elected Board of Tuscola County Road Commissioners be transferred to an appointed Board of Tuscola County Road Commissioners? If approved, the powers, duties and functions of the elected Board of Tuscola County Road Commissioners will be transferred to a Board of Tuscola County Road Commissioners whose members are appointed by the Tuscola County Board of Commissioners.


