TUESDAY, NOVEMBER 4, 2025 IN TUSCOLA COUNTY, STATE OF MICHIGAN**

QUALIFIED ELECTORS PLEASE TAKE NOTICE that any qualified elector who is not already registered, may register to vote at the office of the appropriate City or Township Clerk; the office of the appropriate County Clerk; a Secretary of State branch office or other designated state agency. Qualified Electors may complete the following online at [www.mi.gov/vote](http://www.mi.gov/vote): 1. Verify if registered to Vote. 2. Print a Voter Registration Form to mail to the Local Clerk. 3. Register to Vote online. 4. Update voter registration information such as an address. 5. Track an absentee ballot.

The last day to register in any manner other than in-person with the Local Clerk is **Monday, October 20, 2025**.  
After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.497)  
at the appropriate Clerk's Office during the following dates and times.
