Notice of Drainage Board Meeting To Add Counties to a Drainage District

MURDICK-VAN SICKLAND INTERCOUNTY DRAIN (Tuscola and Sanilac Counties)

This meeting is an opportunity to review the addition of Lapeer County to the Murdick-Van Sickland Intercounty Drain Drainage District. The Drainage District currently consists of lands located in Tuscola County and Sanilac County.

The Drainage Board, which for purposes of this meeting shall include the Tuscola County Drain Commissioner, Sanilac County Drain Commissioner, and Lapeer County Drain Commissioner, shall consider any evidence offered and determine whether the addition of Lapeer County to the Murdick-Van Sickland Intercounty Drain Drainage District is just and equitable. All persons owning lands in the Drainage District or proposed revised Drainage District liable to assessment for benefits and any municipality affected may appear for or against the addition of Lapeer County.

A map depicting the proposed revised Drainage District, including the addition of Lapeer County to the Drainage District can be found enclosed.

Proceedings conducted at this public meeting will be subject to the provisions of the Michigan Open Meetings Act. Public comment will be received at the meeting from anyone owning lands liable to an assessment, or whose lands will be crossed by the drain, or any municipality affected. 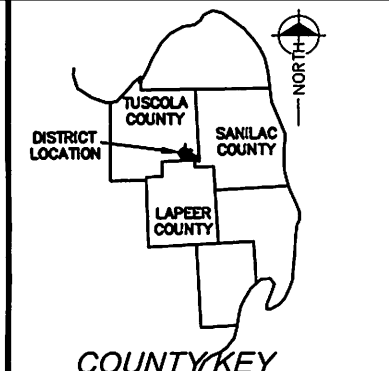
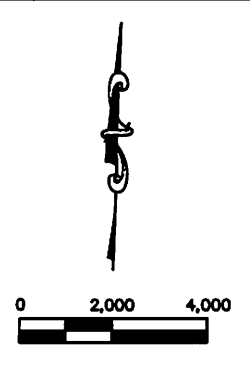
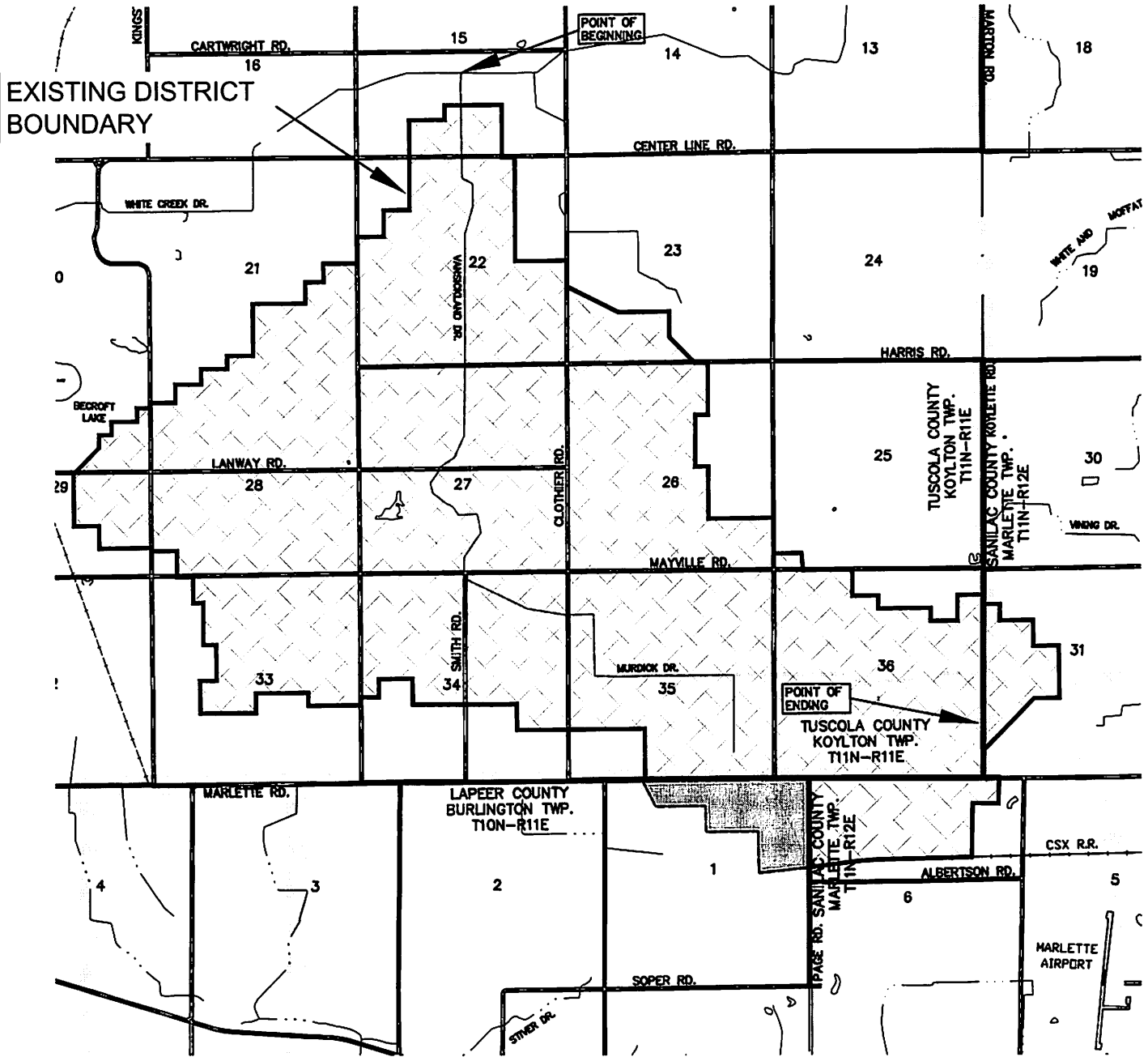
