The Day of Review is an opportunity to review the tentative apportionment of benefits for each parcel and municipality within the Southgate Drain Drainage District with the Drain Commissioner or staff member. The following is a list of any county, township, city, or village to be assessed: Tuscola County, Akron Township, Fairgrove Township, Gilford Township, and Wisner Township.

Attendance at the Day of Review:

- No appointment is necessary.
- The Drain Commissioner, engineers and/or other staff members will be available to assist individuals and make revisions where necessary.
- The computation of costs for the Drain will be available.

Comments submitted in advance must be received by the Drain Commissioner prior to the Day of Review to ensure that they will be considered.

Assessments & Appeal

Drain assessments are collected in the same manner as property taxes and will appear on your winter tax bill. If drain assessments are being collected for more than one (1) year, then at any time you may pay the assessment in full with any interest to date, which will avoid further interest charges.

You may appeal the Drain Commissioner's determination of apportionments to the Tuscola County Probate Court within ten (10) days.

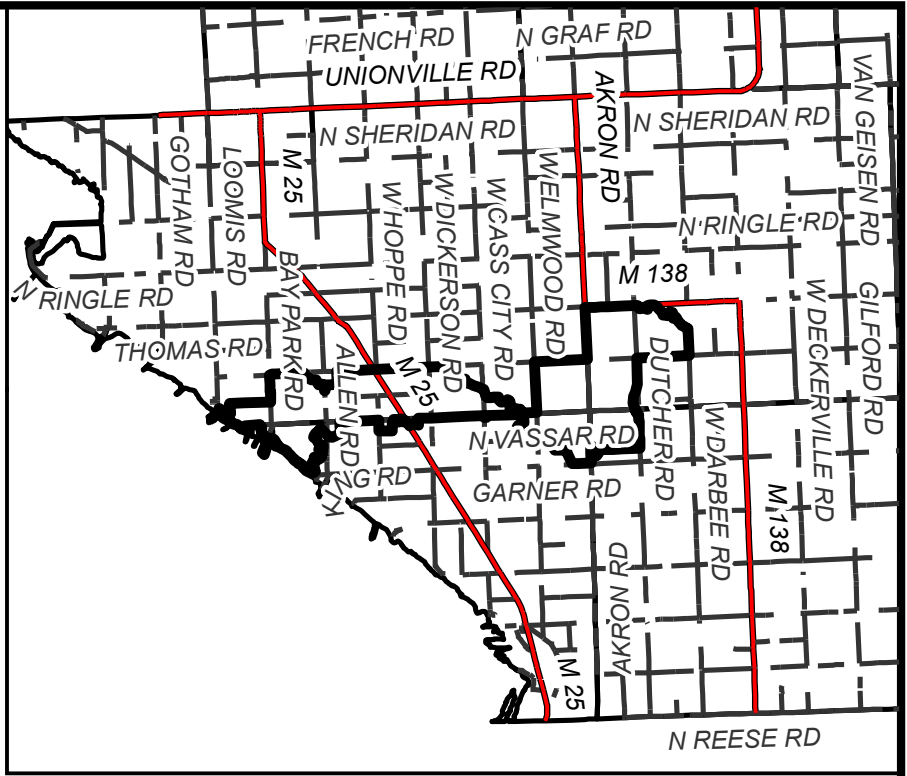

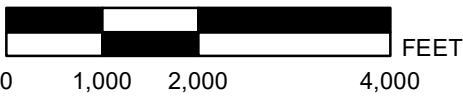
SOUTHGATE DRAIN - S-024
