- h. C. Kapa recommends approval of letter to support Arbela Twp. on their decision of Township rezoning. L. Kester seconds, all voting in favor motion passed.

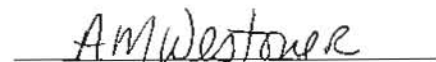
