RE: Trailers

Tuscola County Recycling will be accepting bids on the purchase of 3 Interstate 1 Manufacturing Enclosed Trailers. The following specifications shall be considered in your bid:

1. The 3 trailers shall be Model Number I816TA3XLT, and be Pewter in color.
2. Trailers shall not be V-Nosed, and shall be bumper pull type.
3. Trailers are to have an I-beam frame with cross members 24" O.C at a minimum.
4. Wall framing shall be a minimum 16" O.C
5. Roof framing shall be a minimum of 24" O.C
6. Roof shall be one piece of aluminum.
7. Double axle shall be a minimum of 5200 pound capacity, and shall have electric brakes.
8. Flooring shall be a minimum of 3/4" plywood.
9. Walls shall be a minimum of 3/8" plywood.
10. Trailers shall have a minimum 32" side door with cam lock.
11. Trailers shall have double rear doors (Barn door) with cam locks.
12. Trailers shall have sealed LED lighting.
13. Trailers shall have a minimum 24" stone guard installed.
14. Trailers shall have a replaceable tongue jack and include sand plate and have a 2 5/16 coupler.
15. Trailers shall be wired for a 7 pin connector to connect to our existing trucks.
16. Trailers shall have standard wheels.

All trailers are to have a minimum of a 3 year warranty on axles, frame, and floor.

Closed sealed proposals shall be submitted to the Tuscola County Recycling Center at 1123 Mertz rd Caro Michigan 48723 no later than 4:30 pm on August 26th 2014.
