TUSCOLA COUNTY SHERIFF'S OFFICE
JUNE 2006**

- June 2** Undersheriff James Jashinske attended "Smart Moves Graduation" for the 7th graders of Millington Schools.
- Deputy Michael Mattlin attended the "Smart Moves Graduation" for the 5th and 6th graders of Millington Schools.

- The Tuscola County TEM and the All Hazards Planning Team conducted a full scale dispensing site exercise using Vassar schools. We had over 125 volunteers sign up. We had over 200 participants and first responders, plus many Public Officials including Village, Township, City, and County officials take part and were victims in the event. We had the EOC staff taken by Thumbody bus from Caro to Vassar and they were the first "victims" of the bird flu. They got to see firsthand who, what, when, why, where, and how their decisions in the Emergency Operations Center can and will affect the overall outcome of a disaster. In the Emergency Operations Center we had live video via internet and could watch the exercise unfold through the school's video surveillance cameras. Much of the equipment used in the exercise was purchased through the 2004 Homeland Security Grant funds administered by the Tuscola County Office of Emergency Management. We utilized the school's video equipment, the K-9 Bomb dog was used at the dispensing site, and the RACES radio and video equipment. We had local, county, and state officials assisting in evaluating the exercise.

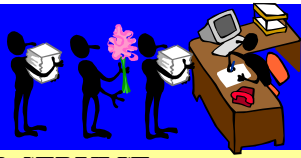
