AUGUST 2006



August 2 Sheriff Thomas Kern and Undersheriff James Jashinske attended the Tuscola County Chief's meeting.

August 7 Sheriff Thomas Kern attended the Dayton Township Board Meeting.

August 10 Undersheriff James Jashinske and Deputy Hofmeister met with the Thumb Cellular officials in regards to Internet access for LEIN and data transfer via laptop's in patrol units.

EMD Patrick Finn partially activated the EOC (Emergency Operations Center) for the Region III Bio Terrorism communications exercise. Thirteen of the fourteen counties participated and we did make contact with all of them. We completed the necessary assignments for our county and I am proud to say that Tuscola County RACES were the lead agency for all the counties. I also attended the exercise critique meeting at the Lincoln Center in Bay City for the regional after action report.

August 14 Sheriff Thomas Kern hosted the Caro Rotary Picnic at his residence.

Undersheriff James Jashinske attended the Tuscola County Gun Board meeting.

August 18 EMD Patrick Finn attended the FY2007 Michigan State Police Emergency Security Division Work Agreement in Cass City.

August 22 EMD Patrick Finn responded to a request for help from the Vassar Police and Fire Departments on a report of dead fish in the Moore Drain in downtown Vassar. The drain was blocked and DEQ was notified and the next morning. The Vassar DPW/WWTP checked the drainage systems. It was discovered that a local business had dumped some floor cleaner into the drain and it killed about 50 fish in the drain. The spiller was advised to make the necessary changes to correct their drain so it does not go directly to the river.

August 29 Sheriff Thomas Kern put on an office safety program for the Cass City Rotary Club.

EMD Patrick Finn responded to a train derailment on Court/Ellington Streets in Caro. The product was shelled corn and it posed no threat. The Caro Police, Fire, and railroad company completed the clean up.

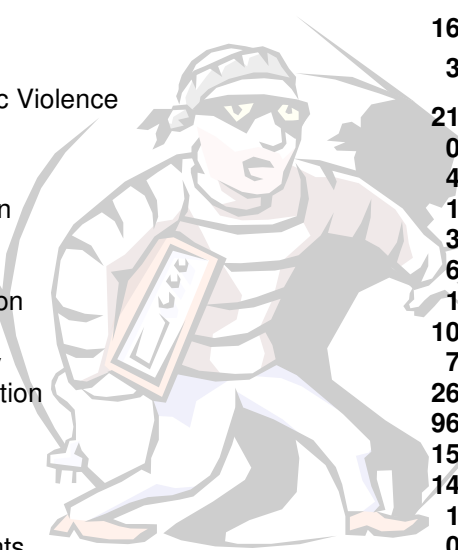

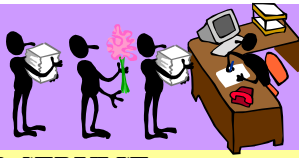
