- February 28 Sheriff Thomas Kern gave a talk to Senior Citizens at the Caro Methodist Church on the awareness of scams and how to avoid them.

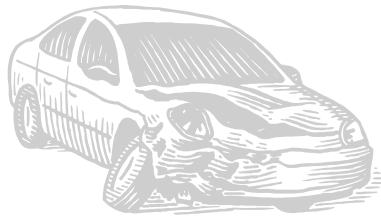

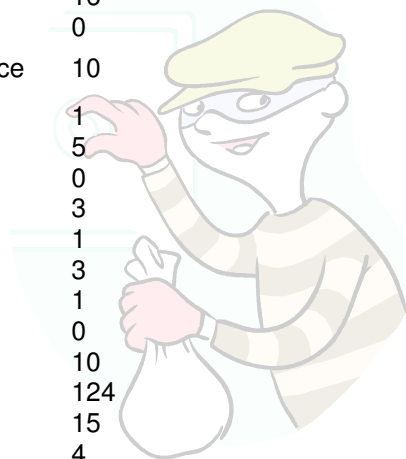

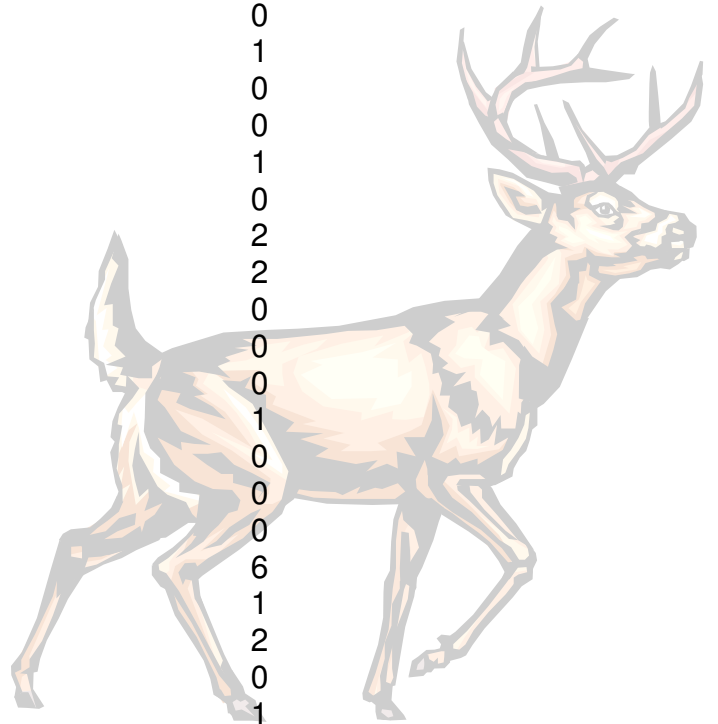
