



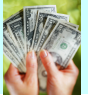
**TUSCOLA COUNTY BOARD OF COMMISSIONERS

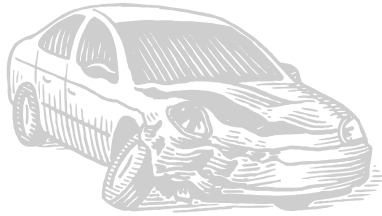

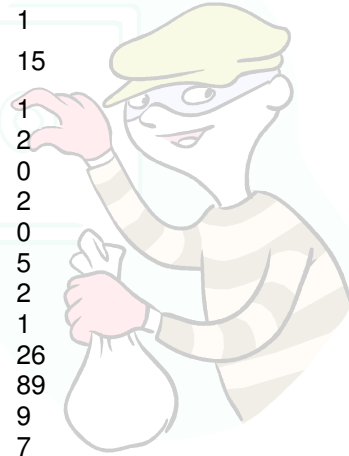

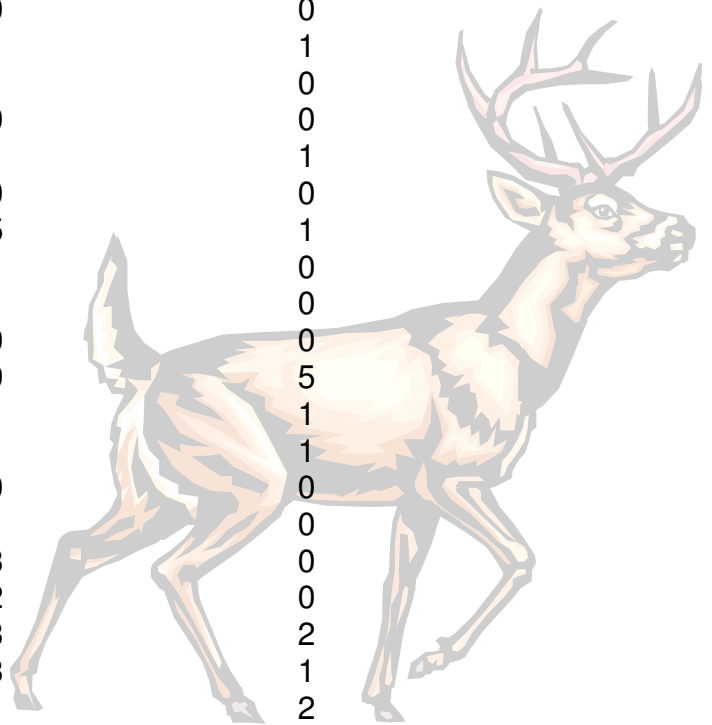
