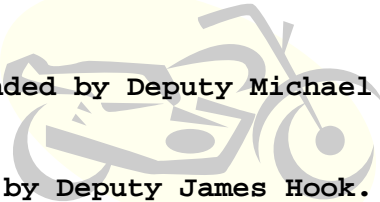
- May 1 Sheriff Thomas T. Kern attended the Senior Police Academy Graduation in Bad Axe.

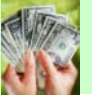

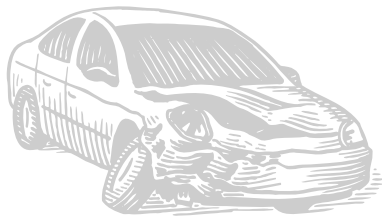

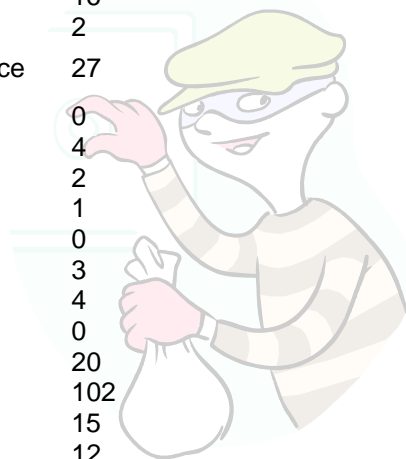
