- June 20 Deputies Steve Roland and Doug Kinney attended an Interview and Interrogation Class at Delta College.

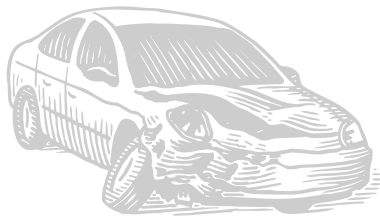

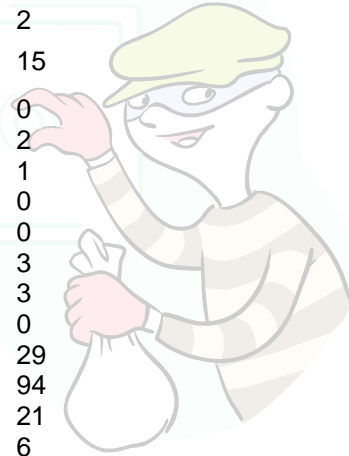

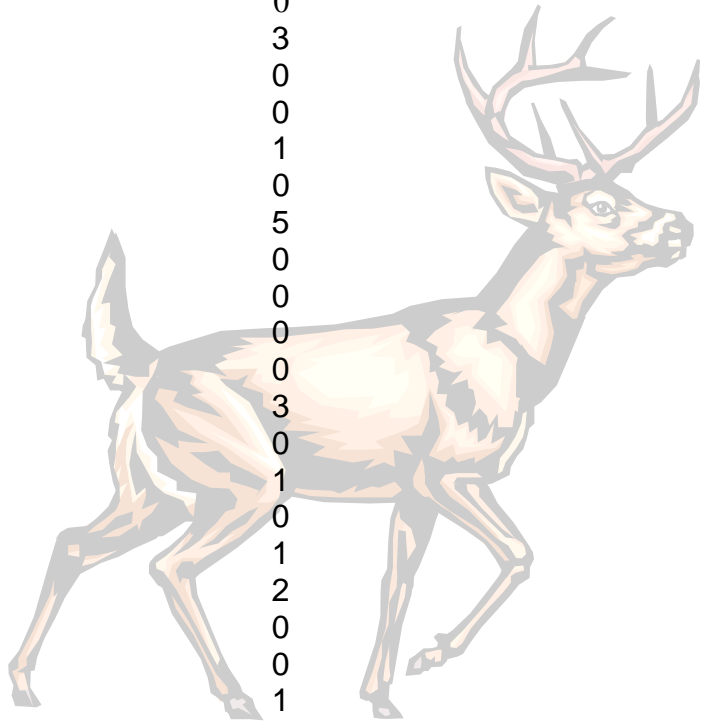
