TUSCOLA COUNTY SHERIFF'S OFFICE  
JULY 2007

- July 7                   The monthly tornado siren test was conducted to test the warning system for Tuscola County residents.
- July 9                   Undersheriff James Jashinske attended the Tuscola County Gun Board meeting.
- EMS Director Patrick Finn received a severe thunderstorm warning and tornado watch that turned into a Tornado Warning for Tuscola County, especially affecting the southern portion of the county. All first responders were notified and put on standby until the weather cleared.
- July 11                 Undersheriff James Jashinske attended the Tuscola County Police Chief's Association meeting.
- July 13                 EMS Director Patrick Finn attended the mandatory bi monthly 3<sup>rd</sup> District Emergency Managers Association meeting in Harbor Beach.
- July 14<sup>th</sup>               Emergency Management conducted the Tuscola County Medical Care Facility exercise drill to test and evaluate their on-site response plan, specifically the evacuation of residents after a natural disaster, a toradic incident. The exercise drill had about 50 participants including first responders from Caro, Vassar, Fairgrove and Mayville Fire departments. Members of the HDC Retired Senior Volunteer Program were role players as victims. Many volunteers were residents of Caro Senior Commons. Thumbody Express provided transportation and the Colwood United Brethren Church provided shelter. The Tuscola County Office of Emergency Management and of course the TCMCF employees, staff and administrators participated. Also, the Sanilac County Office of Emergency Management Director served as an evaluator of the incident response. The Decon/Command trailer was utilized to set up Unfired Incident Command. The staff of TCMCF served a brunch for all participants and we held an exercise critique and openly reviewed the exercise during this time. Great Job Everyone!
- July 16                 EMS Director Patrick Finn was notified of a house explosion with one serious burn victim that had to be transported via flight care. The investigation was being handled by Mayville Fire department at Cat Lake in Dayton Township.

- July 18 EMS Director Patrick Finn attended the Caro Transit Authority Board meeting at the Human Development Commission office in Caro.
- July 19 Sheriff Thomas Kern and Undersheriff Jim Jashinske attended the Sheriff's TRIAD meeting.
- EMS Director Patrick Finn participated in the 14 county Region III Bio-Terrorism Network communications exercise and partially activated the Tuscola County Emergency Operations Center to test our response of the situation.
- Lieutenant Lee Teschendorf and Corporal Brian Harris attended the Thumb Area Community Corrections Advisory Board meeting in Lapeer.
- July 23 Deputy Richard Hofmeister, Magistrate Joe VanAuken, and Undersheriff Jim Jashinske attended Electronic Ticket Demonstration by Advance Public Safety hosted by Saginaw County Central Dispatch in Saginaw.

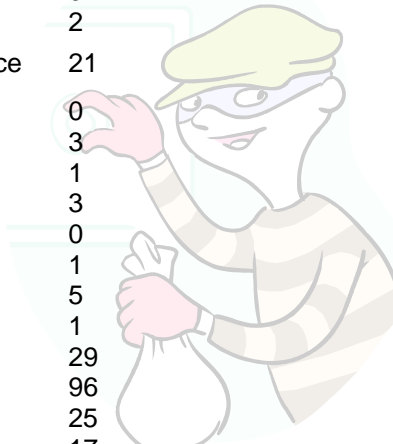

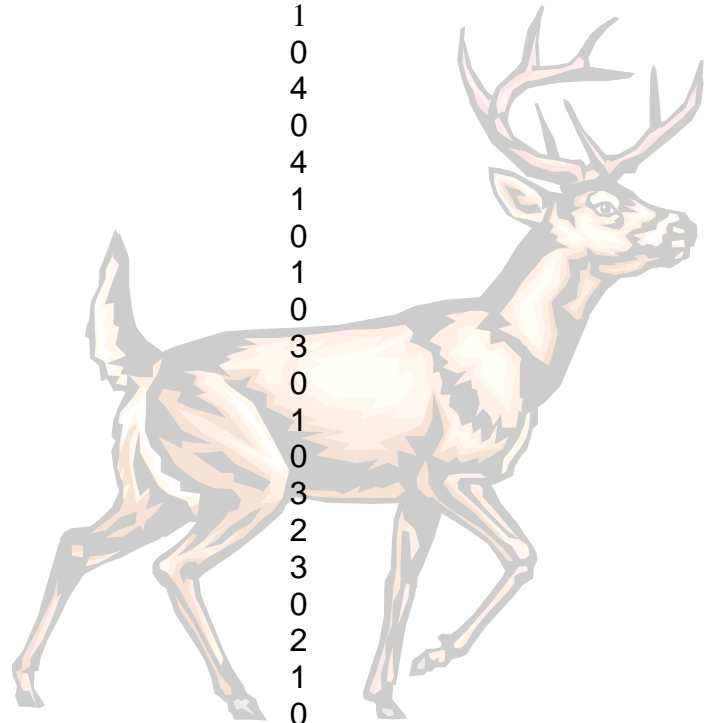
