TUSCOLA COUNTY SHERIFF'S OFFICE  
August 2007

- August 1 EMS director Patrick Finn submitted the FY2008 LEPC Local Emergency Planning Committee Hazardous Materials Emergency Planning grant application to the Michigan State Police Emergency Management Homeland Security Division.
- EMS director Patrick Finn participated in the 3<sup>rd</sup> District State Radio monthly radio check at the Tuscola County EOC (Emergency Operations Center) in Caro.
- August 3 A car seat inspection was hosted in Cass City by the Greater Thumb and Saginaw Area SAFE KIDS. Deputy Ryan Pierce, Trooper Sharkey and Tawnya Stock were technicians at the event. A total of 31 seats were checked and 11 of those were replaced.
- August 4 The monthly Tornado Siren test was conducted to test the warning system for Tuscola County residents.
- August 6 EMS Director Patrick Finn attended the 3<sup>rd</sup> District Emergency Managers Association work meeting and also the 3<sup>rd</sup> District Regional Homeland Security Planning Board meeting in Bay City.
- August 8 Undersheriff James Jashinske attended the Region 3 Law Enforcement Terrorism Committee meeting in Hampton Twp of Bay County.
- August 14 EMS Director Patrick Finn attended the Region 3 BioTerrorism Defense meeting at the Bay Medical learning center in Bay City.
- August 16 EMS Director Patrick Finn was notified of a large natural gas leak in the village of Gagetown. The source was found with no problems and no one had to be evacuated.
- August 19 Sergeant Robert Baxter and Deputy James Hook attended Taser Instructor recertification in Sterling Heights.
- August 22-24 Tuscola County was advised by the National Weather Service that we were under a severe Thunderstorm watch and warning that was upgraded to a Tornado warning. Tornadoes on August 24<sup>th</sup> hit Genessee and Lapeer Counties and lightning hit the Tuscola Central Dispatch tower causing damage.

August 24 EMS Director Patrick Finn attended the Michigan 3<sup>rd</sup> District Regional Planning Board Governance sub committee meeting in Bay City.

August 27 Sergeant Scott Jones met MDOT officials in Bay City.

August 28 Sheriff Thomas T. Kern, Undersheriff James Jashinske, and Lieutenant Leland Teschendorf met with Wayne Schaudt of the Michigan Department of Corrections who surveyed the jail in regards to adding inmate beds.

EMS Director Patrick Finn attended the Saginaw Valley Medical Control Board meeting at Synergy Medical in Saginaw.

Aug 29 EMS Director Patrick Finn attended the Millington Community schools staff in service emergency response training update with Critical Incident Management at the Millington High School.

Tuscola County was advised from the National Weather Service of a Severe Thunderstorm Warning that was upgraded to a Tornado Warning within minutes of each other. Caro, Fairgrove and Cass City areas had minor wind damage and sporadic power outages.

Sheriff Thomas T. Kern's secretary Pamela Shelito attended a Michigan Commission Law Enforcement Standards (MCOLES) training seminar in Lansing.

August 30 Undersheriff James Jashinske attended the Tuscola County Board of Commissioners meeting.

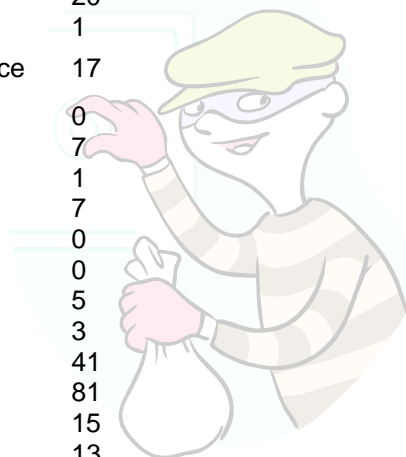

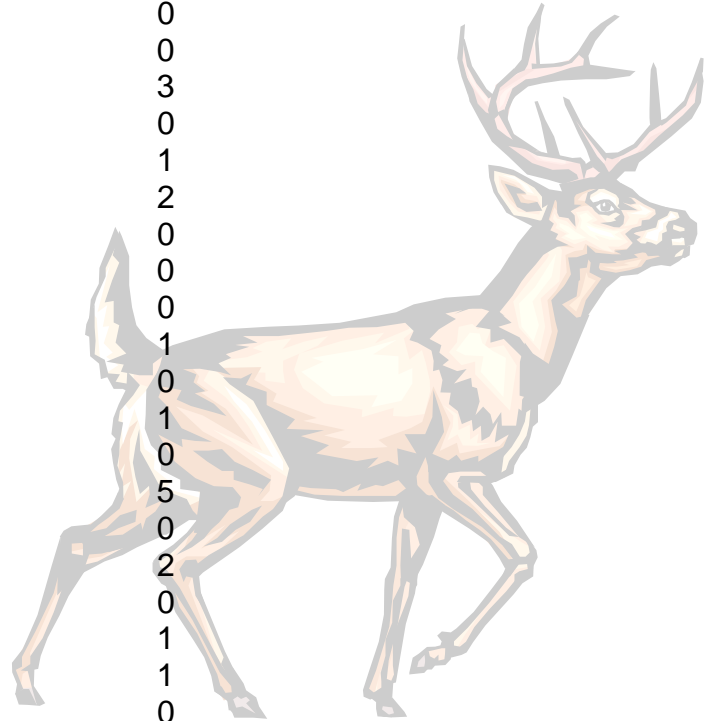
