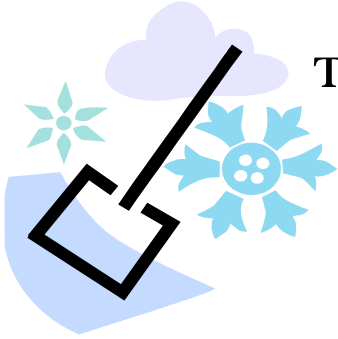


# TUSCOLA COUNTY BOARD OF COMMISSIONERS MONTHLY REPORT - 2008

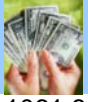
## TUSCOLA COUNTY SHERIFF'S OFFICE

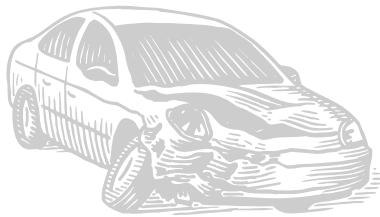

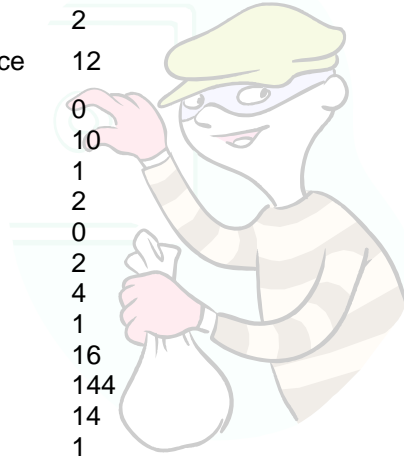
