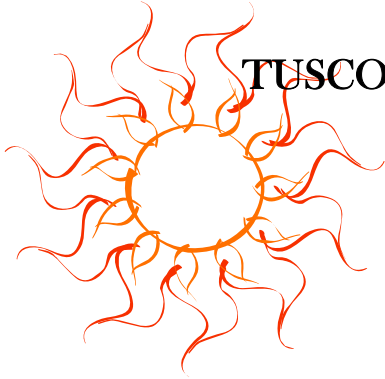


TUSCOLA COUNTY BOARD OF COMMISSIONERS MONTHLY REPORT 2008

Lieutenant James Giroux and Record's Clerk Debbie Mika attended a seminar on Secondary Road Patrol in Roscommon.

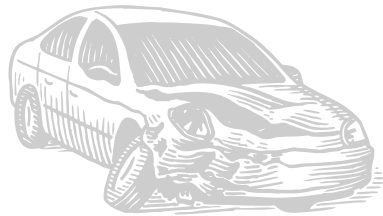

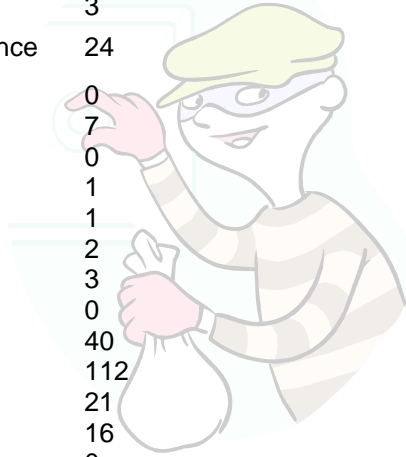
