- Sept 27 Sheriff Thomas T. Kern held the Annual County Auction behind the County Jail.

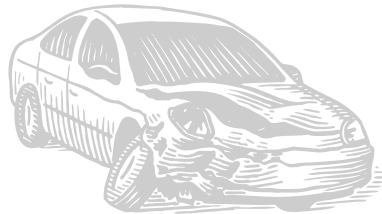

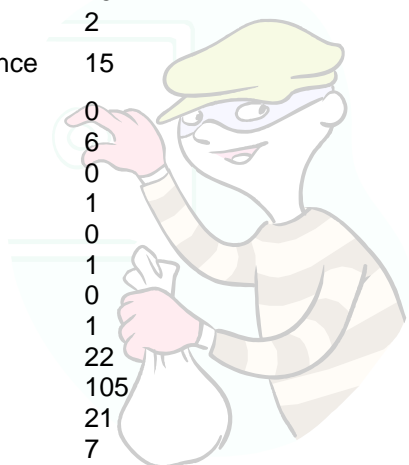
