Oct. 30 Undersheriff James Jashinske attended the Board of Commissioners meeting.

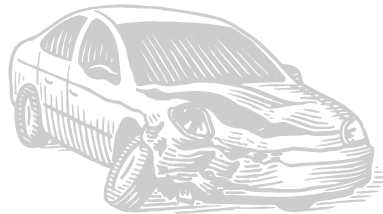

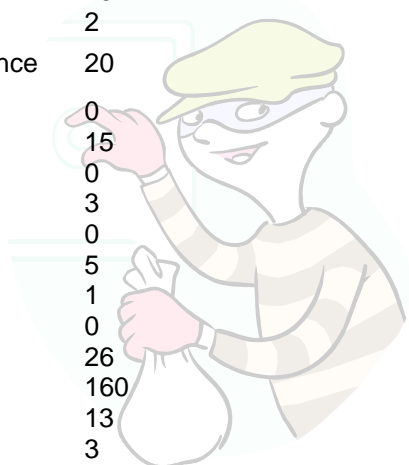
