- April 24 Sheriff Leland Teschendorf attended the Thumb Volunteer Alliance Open House.

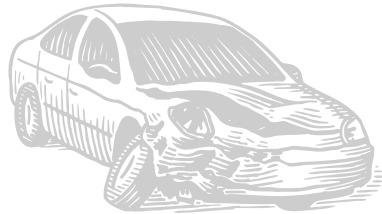
- April 25 Undersheriff Glen Skrent attended the Knights of Columbus appreciation dinner.

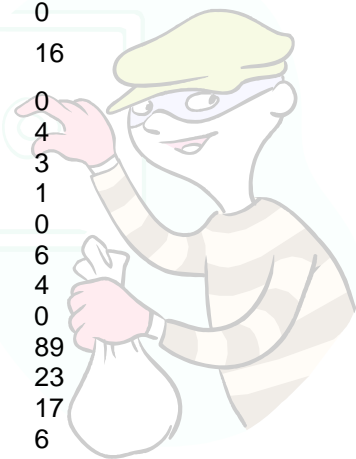
