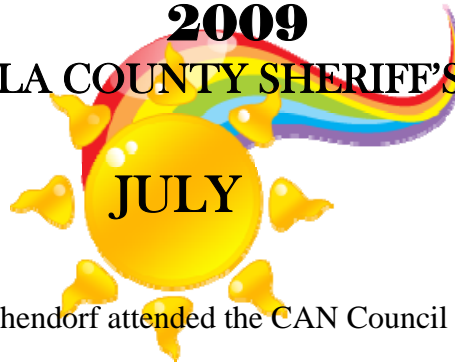


TUSCOLA COUNTY BOARD OF COMMISSIONERS MONTHLY REPORT

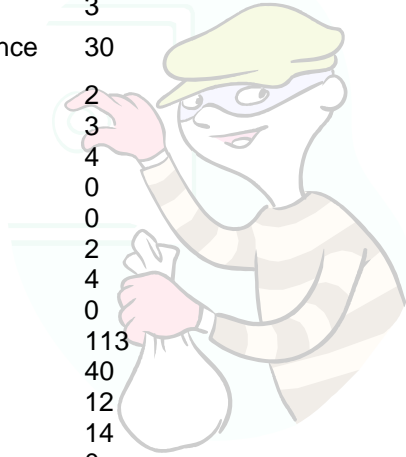
