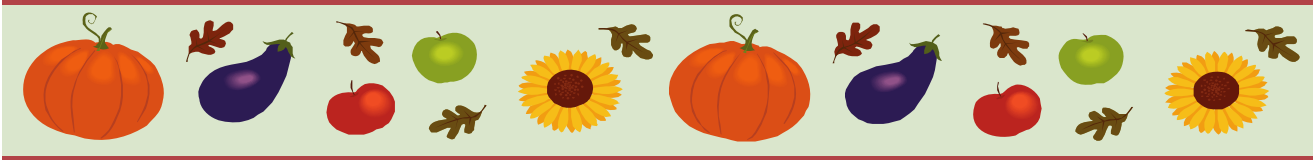

- Correction Officers Gary Stephens and Alexandria Montgomery attended Sudden Deaths in Custody training.

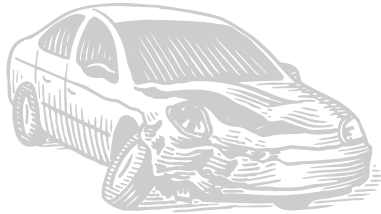

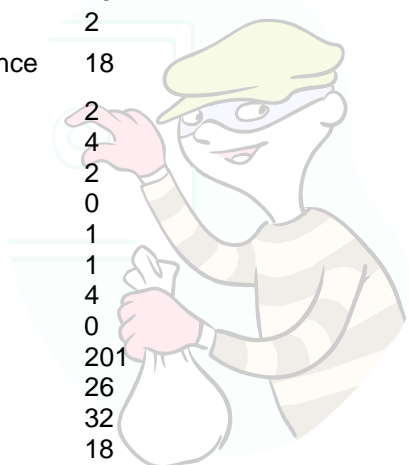
