Dec. 22 Sheriff Leland Teschendorf attended the Underage Drinking Coalition meeting.

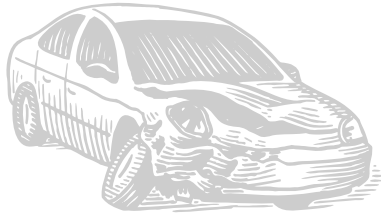

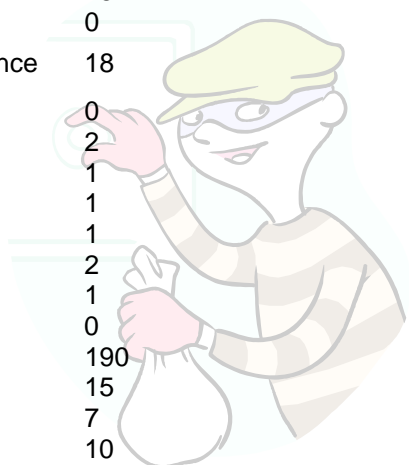
