July 29 Sheriff Leland Teschendorf attended the 4-H small livestock sale at the Tuscola County Fair.

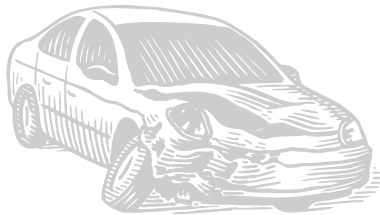
