April 29 PEM Patrick Finn received notification of the Cass River was to exceed flood stage in the City of Vassar from the National Weather Service.

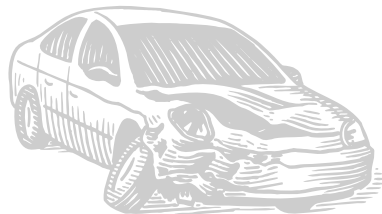
