- June 16 Sheriff Leland Teschendorf attended the graduation Ceremony for the 2010-2011 LEAD Tuscola class.

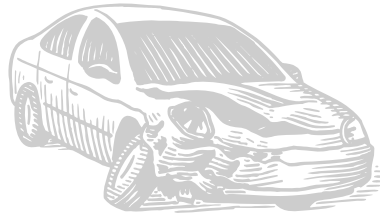
- June 17 Sheriff Leland Teschendorf attended the Tuscola Senior Citizens Fair.

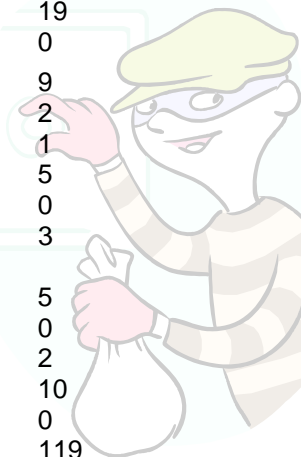
