# JULY 2011

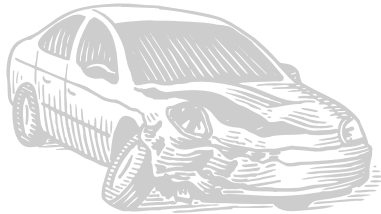
