PEM Patrick Finn attended the Michigan Region 3 Homeland Security communications sub committee at the Bay County Emergency Operations Center in Bay City.

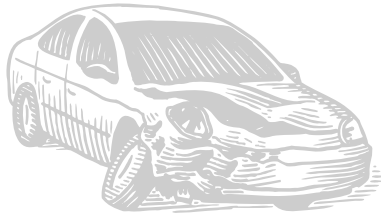

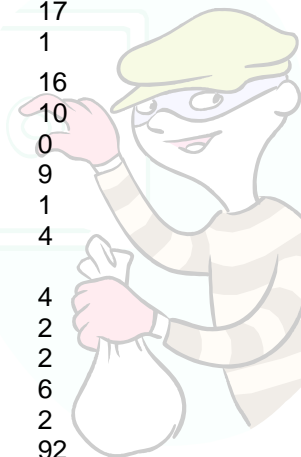
