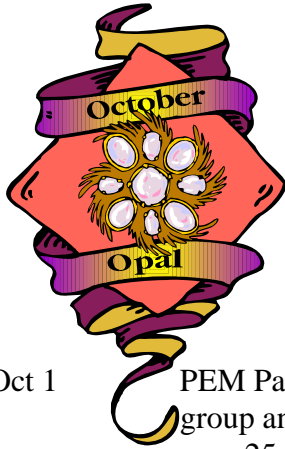


TUSCOLA COUNTY BOARD OF COMMISSIONERS MONTHLY REPORT

- Oct 27 Sheriff Lee Teschendorf attended the visit by the Michigan Supreme Court.

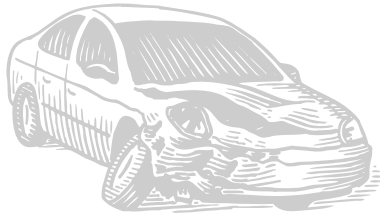
