- Nov 30 Sheriff Lee Teschendorf attended the Arbela Township Social Club luncheon.

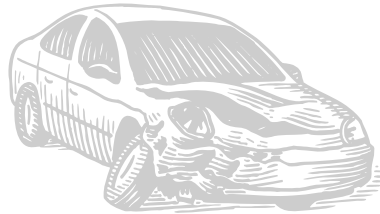

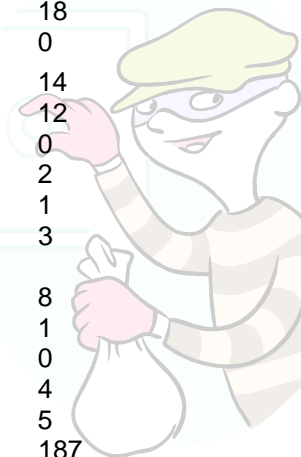
