- Mar 20 Sheriff Leland Teschendorf attended the Caro Squadron #7 Sons of American Legion meeting

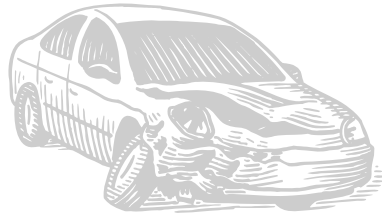
