January 8th, I conducted a walk through safety-security inspection for the Millington School system with Todd Hillman, Emergency Services Coordinator for Sanilac County. 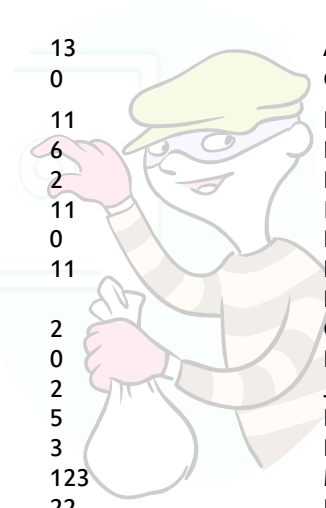

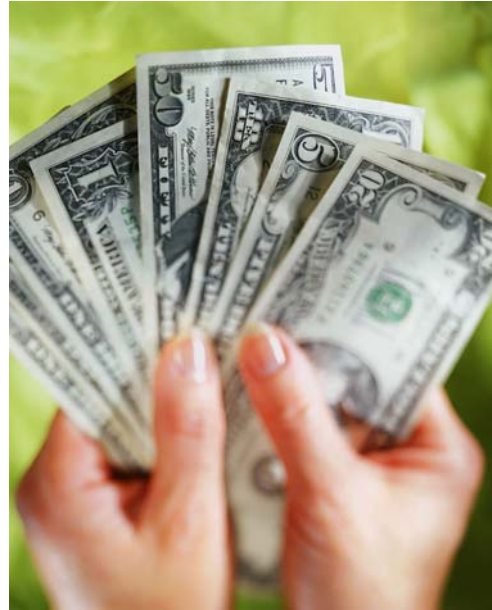
